This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpaths described in paragraph 1 of this order it is expedient that the line of the paths should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the paths into a fit condition for use by the public.

Colchester City Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public rights of way over the land situated at Wick Farm in Chappel known as Footpath 21 Aldham and Footpath 21 Chappel in the City of Colchester and shown by a bold continuous line on the order map numbered PROW-23-03 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be public footpaths over land situated at Wick Farm in Chappel known as Footpath 21 Aldham and Footpath 21 Chappel in the City of Colchester as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-03 contained in this order.

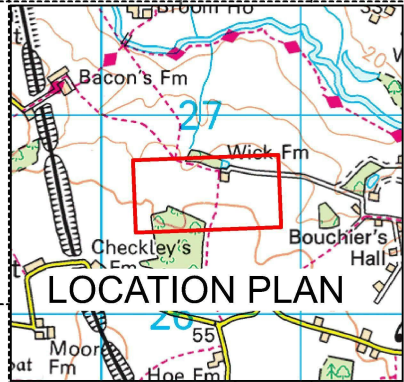

## SCHEDULE

### (PART 1)

#### DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS

A part length of Footpath 21 Chappel of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 59043,26676 on a farm track situated south of the wooded area known as Wick Grove running in an east south easterly direction along the track for a distance of approximately 175 metres to point **B** at grid reference 590598,226722 where it continues in a generally southerly direction along a track crossing the parish boundary to Footpath 21 Aldham for a final distance of approximately 165 metres to point **C** at grid reference 59055,22648 where it continues unaffected.

### (PART 2)

#### DESCRIPTION OF SITE OF NEW PATHS OR WAYS

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a generally southerly direction along a grass track crossing the parish boundary for a distance of approximately 225 metres to point **D** at grid reference 59034,22656 then continuing in a south easterly direction for a final distance of approximately 227 metres to the aforementioned point **C** where it continues unaffected.
