This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Colchester City Council have been consulted as required by section 120(2) of the 1980 Act.

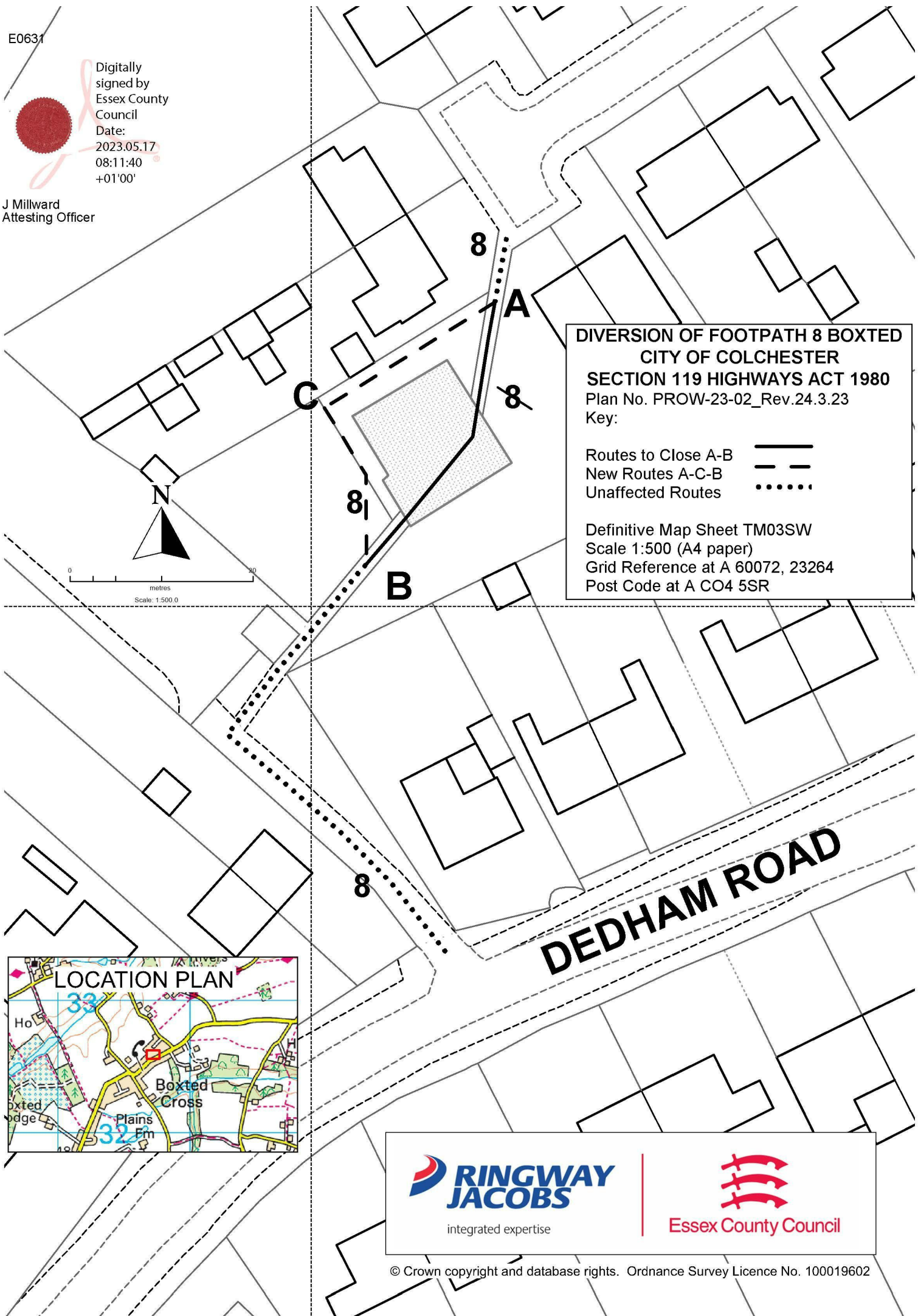
BY THIS ORDER:

- 1) The public right of way over the land situated north of Dedham Road known as FP8 Boxted in the City of Colchester and shown by a bold continuous line on the order map numbered PROW-23-02 rev.24.03.23 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated north of Dedham Road known as FP8 Boxted in the City of Colchester as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-02 rev.24.03.23 contained in this order.

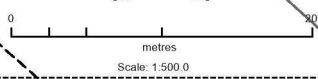

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 8 Bosted of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 60072,23263 from an unnamed road running along a surfaced path in a south south westerly then south westerly direction for a total distance of approximately 33 metres to point **B** at grid reference 60071,23260 where it continues unaffected.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** from an unnamed road running in a generally south westerly direction along a surfaced path for a distance of approximately 22 metres to point **C** at grid reference 60070,23262 then continuing in a south easterly then southerly direction for a final distance of approximately 18 metres to the aforementioned point **B** where it continues unaffected.
