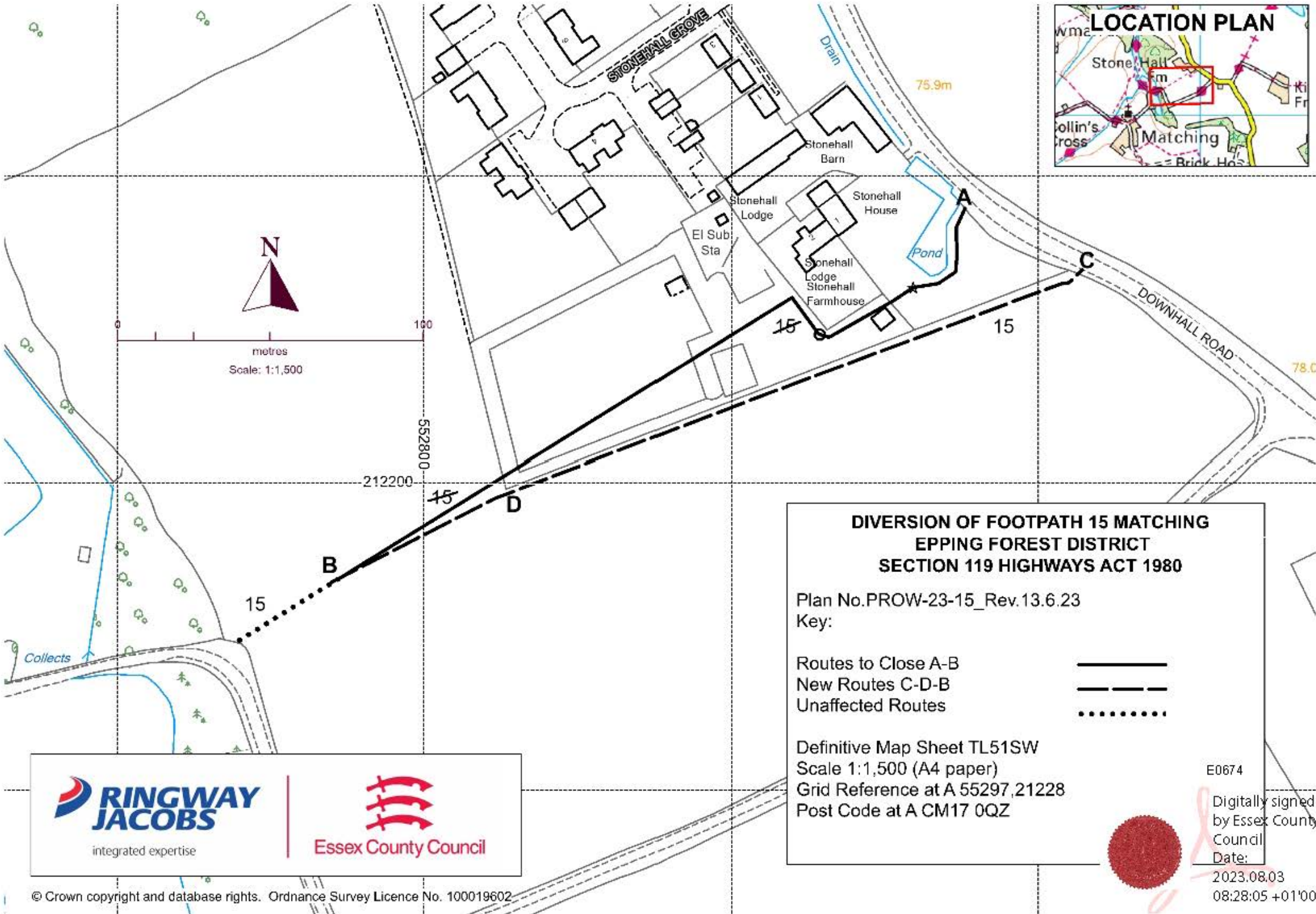
This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted as required by section 120(2) of the 1980 Act.




BY THIS ORDER:

- 1) The public right of way over the land situated west of Downhall Road Matching in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-23-15\_Rev.13.6.23 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated west of Downhall Road in the District of Epping Forest as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-15\_Rev.13.6.23 contained in this order.

## SCHEDULE

### (PART 1)

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 15 Matching of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55297,21228 following the natural surfaced path from Downhall Road in a south then south westerly then north westerly then south westerly direction through boundary features for a total distance of approximately 260 metres to point **B** at grid reference 55274,21215 where it continues unaffected.

### (PART 2)

#### DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 1.5 metres in width shown by a bold broken line on the order map commencing from point **C** at grid reference 55301,21226 running in a south westerly direction along a headland for a distance of approximately 200 metres to point **D** at grid reference 552827,212196 then continuing as a 1 metre cross-field path in a south westerly direction for a final distance of approximately 60 metres to the aforementioned point **B** where it continues unaffected.
