1.	Welcome and Introductions	
	The Chairman welcomed Members, Officers and Guests present.	
2.	Apologies	
	Apologies had been received from Councillor P Keska (EFDC).	
	Declarations of Interest	
	There were no declarations of interest pursuant to the Council's Code of Member Conduct.	

3.	Minutes	
	RESOLVED:	
	That the minutes of the meeting held on 28 September 2020, be agreed by the Panel as a true record.	
4.	Matters Arising from Minutes of the previous meeting	
	Councillor C Pond asked if there had been any updates to LEPP152086 – The Broadway, Loughton – Central Reservation.	
	The HLO advised that she had a meeting with the design team leader and would provide an update at the meeting in March.	SA
5.	Strategic Development	
	The HLM, Sonia Church introduced Matthew Lane, Engineer (Essex Highways) and asked Members if they had any questions regarding S106 and S278 agreements that are attached to some planning obligations.	
	S106 are private agreements made between local authorities and developers and can be attached to a planning permission to make an acceptable development which would otherwise be unacceptable in planning terms.	
	A S278 agreement was a section of the Highways Act 1980 that allowed developers to enter into a legal agreement with the highways authority to enter into an agreement with a third party to deliver improvements on the existing public highway.	
	M Lane advised that he looked at highway improvements and how to mitigate them. S106 monies needed to be spent in the location of the development and not 3 miles down the road.	
	The Chairman commented that she thought the restrictions had been loosened	
	M Lane replied that the distance had to be fair, reasonable and related to the development.	
	Councillor S Kane asked how and when S106 monies were decided, as the first time Members would know about S106 contributions were when they came before a Planning Sub-Committee meeting.	
	M Lane advised that Members would need to engage with the Planning Officers at EFDC.	
	Councillor S Kane stated that S106 contribution discussions were held before the application came to a Planning Sub-Committee meeting and therefore Members were not being able to get involved in these discussions. He stated that Ward Members needed to know in order for the correct questions to be asked.

	K Durrani advised that he would take this back to the Planning Service Director at EFDC and get advice on how Member interaction could fit, he would bring it back to the March meeting.	
	Councillor A Lion asked what the process was for S106 contributions for transport. Would you be able to define the process of how it would link into the District from County?	
	M Lane advised it should be noted that ECCs preference would be for any related transport/highway work, would ideally be delivered by the developer and not a contribution. Each application is looked at on its merits, with internal consultations with relevant teams, including the HLO, with regard to the actual impact of the application and any mitigation that is identified and is considered necessary e.g. the bus stop improvement example below, then this is ideally secured for delivery by condition, and not S106 monies predominantly. Where there is a Local Plan scheme identified in the IDP, or a relevant LHP scheme/proposal, then contributions can be sought under S106 - but ultimately everything must accord with the National Planning Policy Framework (NPPF) paragraph no.56 which states that:	
	<ul><li>"Planning obligations must only be sought where they meet all of the following tests:</li><li>a) necessary to make the development acceptable in planning terms;</li><li>b) directly related to the development; and</li><li>c) fairly and reasonably related in scale and kind to the development."</li></ul>	
	For example, works needed to be completed to install a bus stop shelter and raised kerbs, the recommendation would be to ask the developer to do these works and not take the S106 contribution. This is an example of ECC securing works rather than taking a contribution.	
	The HLM advised that a planning process led by the local authority was a process ECC fed into as a consultee, they do not lead it, is the District that would lead.	
6.	Funded Schemes 2020/21	
	The HLO advised that the report on pages 6-10 of the agenda provided an update on the current position of all schemes with the Epping Forest Local Highways Panel had recommended for inclusion in the 2020/21 programme.	SA
	Members were reminded that the costs supplied were budget estimates only that there was the possibility of a final scheme cost change dependent on issues which may arise during the detailed design and construction. The Panel would be informed of any budget adjustments required on schemes.	
	LEPP191005 – B172 Coppice Row, j/w Loughton Lane, Theydon Bois. To relocate the parking facilities on Loughton Lane further south. Due to the continued objections, this element of the scheme would not proceed. The site would be monitored to see if the works of realigning the kerb line, which had already been completed, would reduce the pattern of personal injury collisions that had been identified.	

	LEPP192003 – Crown Hill, Upshire. The request for build outs and village gateways had to be rescoped to remove the build out element of this scheme due to being unable to maintain the necessary carriageway widths for large agricultural vehicles to pass by the designed build outs.	
	Therefore, due to Crown Hall not being able to have the build outs, there was a surplus of monies left totalling £49,000. If the budget was not utilised in this municipal year then it would have to go back to ECC therefore, to utilise all of the budget, a further seven schemes were allocated the funds which also included additional savings identified from within the existing programme, were used to fund these schemes to be completed in Q4. (page 10 refs 28 to 35)	SA
7.	Report on Schemes Awaiting Funding	
	The HLO advised that the Schemes Awaiting Funding list (attached to the agenda on pages 11-31) identified all the scheme requests which had been received for the consideration of the Epping Forest Local Highways Panel.	
	Members were asked to review these schemes and consider funding recommendations for those they wish to see delivered in 2021/22 and remove any they would not wish to consider for funding.	
	Costs supplied were estimated only and there was the possibility that the final scheme cost could change significantly, dependent upon issues which may arise during the detailed design and construction. Schemes that were still awaiting speed surveys had been delayed due to Covid-19.	
	The HLO advised that any schemes marked in red that the Panel agreed to be removed from the schemes list, would remain on the website in case they needed to be revisited in the future.	
	The Chairman asked whether there was yet any indication of what the budget would be for this coming year.	
	The HLO advised that in the previous 3 years it had been £349,774 but the amount for 2021/22 will not be decided until the County Council budget in February 2021.	
	The HLO advised that she would email LHP Members of all their schemes that had been validated and what was still waiting to be validated, so Members could start to prioritise the schemes in their divisions they would like to be considered for funding in the coming financial year ahead of the March meeting when the programme would be set.	
	Safer Roads	
	A total of £36,000 would need to be allocated to Safer Roads and the 3 schemes on the list were awaiting validation form part of the Casualty Reduction Programme and will need to be funded once Road Safety confirm these schemes.	

#### Traffic Management

The schemes awaiting funding for Traffic Management schemes currently totals  $\pounds$ 449,250. The HLO advised that the schemes marked in red should be removed from the list but asked Members to agree each one. A scheme that was marked in red was against ECC policy or there were no appropriate engineering solutions.

LEPP192026 – Moreton Bridge, Moreton. The validation had been completed and it had been observed that signage warning drivers of the narrow bridge was already in place along both approaches to the bridge, this met the current traffic design criteria. The advisory maximum speed 20mph signage had been rotated to its current orientation and that the sign was correctly located.

**AGREED:** That LEPP192026 would be removed from the Traffic Management list.

LEPP192032 – Colson Road and Ladyfields, Loughton. The speed survey results did not indicate a speeding issue on Ladyfields or Colson Road, Loughton therefore traffic calming would not be considered.

**AGREED:** That LEPP192032 would be removed from the Traffic Management list.

LEPP192039 – Sheering Mill Lane, Sheering. The validation had been completed and it had been observed that there was already illuminated road narrows sign and no further signage should be considered. It was noted that extensive vegetation clearance would be required to ensure visibility of the signage was maintained.

**AGREED:** That LEPP192039 would be removed from the Traffic Management list.

LEPP192042 – Loughton Lane, Theydon Bois. Footway works had been completed in October 2020 to resolve the water pooling issue.

**AGREED:** That LEPP192042 would be removed from the Traffic Management list.

LEPP192046 – Rye Hill Road, North Weald. The speed survey results did not indicate a speeding issue on Rye Hill Road therefore traffic calming would not be considered.

**AGREED:** That LEPP192046 would be removed from the Traffic Management list.

LEPP182031 – B184 Beauchamp Roding. A reduction in the speed limit did not comply with the Essex Speed Management Strategy. We were waiting for the specific location from the County Member where residents required the community bus pick up were having difficulties.

**AGREED:** That LEPP182031 would be removed from the Traffic Management list.

LEPP192006 – Thornwood Common, Epping. The reduction in the speed limit did not comply with the Essex Speed Management Strategy.

**AGREED:** That LEPP192006 would be removed from the Traffic Management list.

LEPP192050 – Gutteridge Lane, Ongar and Rural. The request to close one entrance to the crescent would involve a long legal process and would be unlikely to be progressed by Legal Services. The recommendation would be to clear back the vegetation to make it more open and less desirable to fly tippers.

The HLO advised that she would speak to the EFDC enforcement team to see if they could recommend any further actions to deter fly tippers in that area.

**AGREED:** That LEPP192050 would be removed from the Traffic Management list.

LEPP202005 – High Street Ongar. A request for a Weight Restriction Order would not be possible as Environmental Weight Limits were not permitted on PR1 routes. PR1 County Routes maybe interurban or connection routes, radial feeder or town centre access routes.

It was suggested that this item be left on the Traffic Management list as there was a surgery to be held with Councillor Bentley soon, The HLO advised that this item would come back to the next meeting with any information and advice from the surgery with Councillor Bentley.

**AGREED:** That LEPP202005 would remain on the Traffic Management list.

LEPP202003 – A113 Ongar Road, Abridge. The speed survey results showed no evidence of a speeding issue on this stretch of the A113 Ongar Road, and therefore did not meet the policy guidance to install a VAS.

**AGREED:** That LEPP202003 would be removed from the Traffic Management list.

LEPP202004 – High Street, Ongar. A request for a 20mph speed limit along the High Street was against the Essex Speed Management Survey but it was agreed that this stay on the list until discussions with Councillor Bentley had taken place.

**AGREED:** That LEPP202004 would remain on the Traffic Management list.

LEPP202008 – Beech Lane, Buckhurst Hill. A request for Beech Lane to be made into a one way street was not able to be progressed as not all of Beech Lane fell within the Essex County boundary.

**AGREED:** That LEPP202008 would be removed from the Traffic Management list.

	<ul> <li>LEPP202011 – Forest Road, Loughton. The speed survey results did not indicate a speeding issue on Forest Road and therefore traffic calming would not be considered.</li> <li>AGREED: That LEPP202011 would be removed from the Traffic Management list.</li> <li>Walking</li> <li>The schemes awaiting funding for Walking schemes currently totals £141,000</li> <li>LEPP133015 – Hemnall Street, Epping. The installation of a new footway on the south-western verge of Hemnall Street was feasible, however this would require additional works and therefore increase the cent of the scheme as</li> </ul>	
	require additional works and therefore increase the cost of the scheme as opposed to installing the footpath on the opposite side of Hemnall Street. It was recommended that the footway be installed on the north-eastern side to avoid these additional problems. This scheme cannot progress until the land issues have been resolved with the City of London, who own the land required to install a footway.	
	<b>AGREED:</b> That LEPP133015 would remain on the Walking list until the land issues had been resolved.	SA
	LEPP203001 – Colebrook Lane, Loughton. The pedestrian/vehicle conflict survey did not meet the level to install a crossing point. The speed survey results did not indicate a speeding issue on Colebrook Lane, therefore traffic calming would not be considered.	
	AGREED: That LEPP203001 would be removed from the Walking list.	
	Passenger Transport	
	The HLO advised the Panel that provision of bus shelters is currently on hold, as we are waiting for ECC to announce the preferred Contractor. This has also been delayed due to Covid-19. Cllr Bentley has sent a letter out regarding the delays to all County Members, explaining the current situation.	
	LEPP195002 – Englands Lane, Loughton. The request for a formalised bus stop with a pole and flag on both sides of the road may no longer be required due to bus operator changes.	
	<b>AGREED:</b> That LEPP195002 would be removed from the Passenger Transport list.	
8.	Any Other Business	
	Councillor R Gadsby stated that a way forward needed to be found regarding the Crown Hill scheme to settle the anxiety of the residents.	
	The HLO advised that having considered the strong representation of residents which is supported by Cllr Gadsby, this had been discussed	

	with Road Safety and Design Engineers and the most appropriate way forward is to ask the Epping Forest LHP to consider funding a route- based study along the 30mph section of Crown Hill and Horseshoe Hill, in the coming new financial year. A report of any recommended engineering measures can then be shared with the County Member and residents, to agree the most appropriate way forward, for the panel to then consider the funding these measures in 2022-23 financial year.
