

**The Essex County Council (Various Roads, Epping Forest) (40MPH, Restricted Road, 20MPH Speed Limit & Zone) Order 2012**

The Essex County Council ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1), 84(1)(a) and 84(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:-

1. The roads detailed in Schedule 1 to this Order shall become restricted roads for the purposes of section 81 of the Act.
2. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 2 to this Order.
3. No person shall cause or permit any vehicle to be driven at a speed exceeding 20 miles per hour on the lengths of road specified in Schedule 3 and 4 to this Order.
4. Schedule 2 of 'The Essex County Council (B1393 High Street et al, Epping) (Combined Speed Limit) Order 2008' is hereby revoked insofar as it relates to B1393 High Road and Theydon Road only, all other restrictions will remain in force.
5. 'The Essex County Council (A104 and A1069, Epping) (40mph Speed Limit) (Part) Order 2004' is hereby revoked.
6. Schedule 2 of 'Epping Forest District (Upshire Village, Upshire) (30 & 40 Miles Per hour Speed Limit) Order 1996' is hereby revoked insofar as it relates to Crown Hill only, all other restrictions will remain in force.
7. 'Epping Forest District (Waltham Abbey Link Road and Sewardstone Road) (40 Miles Per Hour Speed Limit) Order 2002' is hereby revoked insofar as it relates to Daws Hill only, all other restrictions will remain in force.
8. 'Essex County Council (Various Roads, High Beach) (Speed Limits) Order 1995' is hereby revoked.
9. 'The Essex County Council (Various Roads, High Beach) (20 mph Speed Limit) Order 1997' is hereby revoked.
10. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those regulations.
11. This Order shall come into operation on 2 March 2012 and may be cited as The Essex County Council (Various Roads, Epping Forest) (40MPH, Restricted Road, 20MPH Speed Limit & Zone) Order 2012

**Schedule 1 – (Restricted Road)**

Road	Description
Earl's Path	From its junction with the A104 Robin Hood Roundabout in a south easterly direction to a point 10 metres from the southwest kerb line of Smarts Lane.
Wake Road	From its junction with Woodridden Hill (A121) south westwards to a point 95 metres northeast of its junction with Nursery Road, a distance of 1760 metres.
Claypit Hill	From its junction with Pynest Green Lane south westwards to its junction with Wake Road.
Forest Side	From a point 97 metres south of its junction with Honey Lane (A121) southwards to its junction with Pynest Green Lane.
Cross Roads	From a point 53 metres south of its junction with Nursery Road south eastwards to a point approximately 61 metres northwest of its junction with Epping New Road (A104)
Avey Lane	From a point approximately 77 metres east of its junction with Sewardstone Road, south eastwards to a point approximately 62 metres northwest of its junction with Manor Road.
Mott Street	From its junction with Sewardstone Road generally eastwards to a point approximately 26 metres west of its junction with Avey Lane.
Church Road	From its junction with Mott Street generally south westwards to its junction with Lippitts Hill.
Lippitts Hill	From its junction with Mott Street generally south eastwards to its junction with Church Road.

**Schedule 2 - 40MPH Speed Limit**

Road	Description
B1393 High Road	From a point approximately 75 metres from the extended western kerblines of Bury Lane to its junction with the B1393 Epping Road, an approximate distance of 1809 metres.
B1393 Epping Road	From its junction with the B1393 High Road to its junction with the A121 Wake Arms Roundabout.
A121 Honey Lane	From a point approximately 58 metres west of the extended kerb line of Waltham Abbey Jewish Cemetery in an easterly direction to its junction with A121 Woodridden Hill.



A121 Woodridden Hill	From its junction with the A121 Honey Lane, in an easterly direction, to its junction with the A121 Wake Arms Roundabout.
A121 Goldings Hill	From its junction with the A121 Wake Arms Roundabout in a southerly direction to a point 8 metres from the northwest kerb line of Baldwins Hill.
B172 Coppice Row	From its junction with the A121 Wake Arms Roundabout in an easterly direction to a point on Coppice Row, 110 metres northwest of the common boundary of the properties Forest Edge and Ye Old Almshouse.
A1069 Rangers Road	From its junction with the A104 Epping News Road in a south westerly direction for a distance of approximately 520 metres.
A104 Epping New Road	From its junction with the A121 Wake Arms Roundabout in a south westerly direction to a point 67 metres north of Fernside.
Theydon Road	From its junction with the B1393 in a southerly direction to its junction with Piercing Hill.
Piercing Hill	From its junction with Theydon Road in a southerly direction to a point approximately 220 metres north of its junction with Morgan Crescent.
Crown Hill	From its junction with the B1393 in a westerly direction to its junction with Copt Hall Green.
Copt Hall Green	From its junction with Crown Hill in a westerly direction to a point approximately 2.5 metres west of the south east boundary of 'Ferns Hollow', Crown Hill, Upshire.
Cross Roads	From its junction with the A104 Robin Hood Roundabout in a north westerly direction for a distance of approximately 61 metres.
Forest Side	From its junction with A121 Honey Lane for an approximate distance of 97 metres in a southerly direction.
Woodgreen Road	From its junction with A121 Honey Lane for an approximate distance of 60 metres in a northerly direction.
Daws Hill	From its junction with Sewardstone Road to its junction with Bury Road.
Bury Road	From its junction with Daws Hill to a point approximately 8 metres north of the northern side of the access road to Knoll House.
Avey Lane	From its junction with Sewardstone Road to a point 77 metres east of that junction.

### **Schedule 3 – 20MPH Speed Limit**

<b>Road</b>	<b>Description</b>
Wellington Hill	From its junction with Pynest Green Lane to a point approximately 120 metres northwest of its junction with Manor Road an approximate distance of 720 metres.
Rat's Lane	From its junction with Wellington Hill southwards for a distance of 130 metres.

### **Schedule 4 – 20MPH Zone**

<b>Road</b>	<b>Description</b>
Manor Road	From its junction with Avey Lane generally north eastwards to its junction with Wake Road.
Cross Roads	From its junction with Mott Street south eastwards to a point

	approximately 53 metres south of its junction with Nursery Road.
Avey Lane	From a point 62 metres northwest of its junction with Manor Road south eastwards to its junction with Mott Street.
Nursery Road	From its junction with Cross Roads north eastwards to its junction with Wake Road.
Mott Street	From its junction with Avey Lane, generally in a westerly direction, for an approximate distance of 26 metres.
Wake Road	From a point approximately 95 metres north east of its junction with Nursery Road, south west to its junction with Manor Road.
Reservoir Road	From its junction with Mott Street and Avey Lane north eastwards to its junction with Manor Road.
Pynest Green Lane	From its junction with Avey Lane north eastwards to its junction with Claypit Hill.
Wellington Hill	From its junction with Manor Road north westwards for a distance of approximately 110 metres.
Beech Hill Gardens	From its junction with Pynest Green Lane in a north westerly direction to its termination.
Forest Close	From its junction with Pynest Green Lane north westwards to its termination, a distance of 40 metres.
Church Lane	From its junction with Cross Roads to its junction with Manor Road, an approximate distance of 200 metres.
