MALDON DISTRICT LOCAL HIGHWAYS PANEL MEETING – 16 DECEMBER 2016 Council Chamber, Maldon District Council, Princes Road, Maldon – at 9.15am

MINUTES

1. Apologies for absence

An apology for absence was received from Councillor R G Boyce MBE, CC.

2. Minutes of Meeting – 23 September 2016

RESOLVED that the Minutes of the meeting of the Local Area Highways Panel ("the Panel") held on 23 September 2016 be approved and confirmed.

3. Matters arising from Minutes of the Previous Meeting:

The Highways Liaison Officer gave an update to the Panel on the following matters arising:

Minute Number 3

Lower Burnham Road, 600m west of j/w Rectory Lane – this item was now on the Potential Schemes List.

Minute Number 4

Item 1 – LMAL 142003 – Viking Road/Dorset Road/Wordsworth Road – monthly inspections of verges were being undertaken and photographic evidence was being produced.

Item 27 – LMAL 162080 – The Street/Woodham Road, Stow Maries - the Parish Council had replied to the Highways Liaison Officer and advised that they did wish the scheme to progress. The Parish Council had been advised that this scheme would be a first stage scheme, subject to review.

Minute Number 5

Item 17 – LMAL 152064 – Steeple Road near j/w Grange Avenue and Mayland Green, Mayland – this scheme had now been deleted.

Item 33 – LMAL 152053 – B1019 Maldon Road, Ulting near j/w Ashfield Farm Road – an email explaining why this scheme had been deleted had been sent to the local business concerned.

Item 36 – LMAL 152040 – The Street, j/w Great Totham Road, Wickham Bishops – an email had been sent to Wickham Bishops Parish Council to inform them that this scheme had been deleted.

At this point Councillor M F L Durham advised the Chairman that he had replaced Councillor J V Keyes on the Local Area Highways Panel at the Statutory Annual Meeting of Maldon District Council, but he had not been receiving papers for the meetings of the Panel. The Chairman requested that this be rectified forthwith.

4. Approved Works Programme

The Chairman advised the Panel that he hoped to be able to agree in principal the Approved Works Programme at this meeting, working on the assumption that Essex County Council would be allocating the same amount in 2017/18 for capital works as for the previous financial year – i.e. \pounds 200k. There was, of course, no guarantee that this would be the amount allocated to the Maldon District Local Area Highways Panel.

Officers should be given clear instructions that there must be completion dates of not later than March 2018 for schemes on the Approved Works Scheme for the forthcoming year. The Chairman requested that Officers divide the schemes into quarters and distribute the schemes evenly in to those quarters.

The Approved Works Programme, an updated version of which was circulated to Panel Members, contained scheme descriptions and allocated budgets for schemes. Appendix 1 to these Minutes shows the Approved Works Programme and scheme status as discussed at the meeting. The Chairman had expressed to Officers that schemes that had been approved by the Cabinet Member as long ago as 2014 were being carried forward to 2017 and this was not acceptable. Schemes should stay in the financial year in which they had been approved, unless they could not be completed, otherwise the money allocated for those schemes would be lost.

It was noted that those schemes shaded grey were cancelled and would be removed from the programme, whereas those items shaded green were completed. Where an update had been provided by Officers, this was shaded in yellow.

Item 4 – LMAL 142029 – King Street/Queen's Avenue, Maldon – the delay on this scheme was unacceptable, unless there was a legal process to be undertaken. A recommendation would be made to the Cabinet Member for a supplementary estimate

for doing these works in the next financial year, or for this scheme and the money allocated to it, to be carried forward.

Item 6 - LMAL 152002 - Fish Street - 20mph speed limit - the delay on this scheme was unacceptable, unless there was a legal process to be undertaken. A recommendation would be made to the Cabinet Member for a supplementary estimate for doing these works in the next financial year, or for this scheme and the money allocated to it, to be carried forward.

Item 8 – LMAL 152006 – Burnham Road – Vehicle Activated Sign (VAS) – again, there was an unacceptable delay on this scheme and a recommendation to the Cabinet Member would be made for a supplementary estimate for doing these works in the next financial year, or for the works and the sum of money allocated to the scheme to be carried forward. Following a question, the Highways Liaison Officer advised that Traffic Signs Regulations and General Directions had changed in April 2016, so that it was now possible to install a single speed terminal sign whereas previously two signs were required. It was hoped that this would be fairly quick to be installed following the legal process for new regulations being completed. Provided residents responded positively to the new formal consultation, it was hoped that this scheme would be delivered within the next financial year.

Item 15 – LMAL 158001 – Bridleway 25 – drainage/surface improvements – the leak that was causing issues had now been fixed and the need for the drainage improvement was nolonger required this scheme was to be deleted. The Chairman advised that if the issues occurred again, then the scheme could be brought back to the Panel.

Item 27 – LMAL 162031 – London Road (Cemetery to start of 30mph limit), Maldon – 40mph buffer – the Panel was advised that the Police were supportive of these measures.

Item 31 – LMAL 162027 – B1021 Church Road (j/w B1010 Maldon Road to j/w Marsh Road), Burnham-on-Crouch – Zebra crossing – the Highways Liaison Officer advised the Panel that a large element of the money for this scheme was for planing off and resurfacing works. The Panel had requested that a revised scheme be considered. There was a resurfacing scheme in 2017/18 that could be extended through the area of the Zebra crossing which would remove the need for this element within the zebra crossing estimated costs. The revised cost was approximately £67k and negotiations were still be held with the third party for a contribution of £45k with the Panel to provide the remainder of the cost. It was hoped that civil works would take place in the last quarter of this financial year and that the final works would be completed during the 2017/18 financial year, subject to agreement on the scheme finances.

Item 34 – LMAL 162039 – Witham Road/The Street, Wickham Bishops – Priority Working/Build Outs - The Panel was advised that the feasibility study should be completed by March 2017. This study may result in some potential schemes being added to the Potential Schemes List for consideration at the March 2017 meeting.

The Chairman reiterated his request to Officers to schedule completion dates in to quarters for 2017/18 so that the Panel could understand the estimated completion

dates for schemes on the Approved Schemes List. If that information was available, it would enable the Panel to follow through the completion process more logically.

5. Potential Schemes List 2016/17 – Version 22

The Chairman pointed out to the Panel that as part of the Essex County Council 2017/18 budget it was believed that the Capital budget for the Maldon District Local Area Highways Panel from Essex County Council would remain at $\pounds 200k$. It was recommended that for 2017/18 the Panel made further scheme funding recommendations to create a $\pounds 280k$ rolling programme of highway improvement works.

The Panel reviewed the schemes on the Potential Schemes List and prioritised those schemes they would like to make 2017/18 funding recommendations against and deleted those schemes that they did not wish to consider for future funding.

Safer Roads

Item 1 – Lower Burnham Road 600m west of j/w Rectory Lane, Latchingdon – the Panel were advised that this scheme should have a high degree of priority and it was agreed that this scheme would remain green.

Traffic Management

Item 4 – B1022 Maldon Road, Great Totham – the Highways Liaison Officer advised that following a speed survey there was found to be reasonable compliance with the current speed limit. There was a suggestion that roundels be placed on the carriageway. However, there was concern that this would not addess speeding issues during darkness. This scheme would remain amber.

Item 5 – Hackmans Lane, Cock Clarks – Mrs P A Channer CC advised that this scheme was in fact in the parish of Purleigh.

Item 6 – Lawling Avenue, Heybridge – the Chairman advised the Panel that following a speed survey, there was good compliance with the current speed limit. This item would remain amber as there were still concerns about parking/speeding in that area.

Item 8 – B1019 Maldon Road and B1018 Witham Road, Langford – following a speed survey there was clear compliance with speed limits and it was not justifiable to keep this scheme on the potential schemes list. It was agreed to delete this scheme.

Item 13 – Bowling Club, Park Drive, Maldon – Councillor Mrs P A Channer CC advised the Panel that residents were very concerned about the speed in this area. However, the speed data indicated good compliance and furthermore the requirements for a VAS to be installed were not met. The Chairman advised that the Cabinet Member would be unlikely to override this scheme due to the speed data that had been collected. Councillor Miss M R Lewis asked that if a reduction in the problem with "boy racers" had reduced the concerns in this location. The Highways Liaison Officer would request that a further speed survey be undertaken and this scheme would remain amber for the time being.

Item 16 – Market Hill j/w High Street, Maldon – the Chairman agreed with Officers that there should not be any additional signage put in place. The Highways Liaison Manager advised the Panel that, in terms of traffic management, signage would not usually be installed unless one car park was significantly being under-used. It was agreed to leave this scheme in abeyance for the time being.

Item 17 – White Horse Lane, Maldon – Councillor Mrs P A Channer advised the Panel that this issue had been raised by Maldon Town Council as there were concerns about elderly residents utilising the road to access Maldon town centre. Following a discussion, it was agreed that this scheme should, on balance, be deleted.

Item 22 – Old Heath Road, Southminster – Councillor R Pratt declared an interest in this item as he lived in Old Heath Road and stated that he would leave the Chamber for this item. This item would be deleted.

Councillor R Pratt returned to the Chamber at this point in the meeting.

Item 23 – Blackhouse Farm Cottages, Steeple Road, St. Lawrence – the Panel advised that there have been other incidents in this locality, despite the speed survey showing good compliance with speed limits. It was agreed that the Highways Liaison Officer would contact the road safety team to look at this location to see if any further incidents have occurred.

Item 28 – Beckingham Street/Tolleshunt D'Arcy Road, Tolleshunt Major – This scheme was very expensive and would require the acquisition of land if it were to be implemented.

Item 34 – Herbage Park Road/Church Hill/Rectory Road, Woodham Walter – Councillor M F L Durham advised that this was actually in Woodham Mortimer. He further advised the Panel that speed watches had been carried out in this location. The Parish Council had raised £5k which they were happy to contribute towards the installation of a Speed Indicator Device (SID) if the Panel could provide the remainder of the cost. The Highways Liaison Officer would take a briefing note on this back to the Cabinet Member.

The comments about the Parish Council's contribution would be added to this item and it would be changed to green, so that it was on the provisional list for the Approved Works Programme. However, it would still require Cabinet Member signoff. It was agreed that if this scheme went ahead other parishes would be advised that it was a good way of partnership working.

The Chairman thanked the Panel for their work on this.

6. Highways Rangers Work Summary – October - November 2016

A request was made that a Public Right of Way on Stock Terrace, Heybridge be looked at by the Highways Rangers, as currently this was impassible.

The Panel noted the Highways Rangers Work Summary.

7. Any other Urgent Business

- (i) Items requested by Panel Members
 - Councillor Mrs M E Thompson requested that yellow lines be installed at Roebuck House Corner, Church Street, opposite McColl's in Tollesbury as there was a major problem with parking there. The Highways Liaison Officer would liaise with Tollesbury Parish Council on this issue.
 - Councillor Mrs M E Thompson also requested that the Highways Liaison Officer contact Little Totham Parish Council regarding the blind bend at Beckingham Business Park.
 - Councillor M F L Durham advised that Woodham Mortimer Parish Council had requested the zig zag lines outside what is now the preschool be extended, as this was on a t-junction which was dangerous. The Highways Liaison Officer would send the LHP application form to Woodham Mortimer Parish Council for completion.
 - Councillor Mrs P A Channer CC advised that residents had concerns about speeding on Essex Road, Maldon and requested the imposition of a 20mph speed limit. The Highways Liaison Officer advised that there was good compliance with existing 30mph speed limits at that location and the scheme validation findings would be on the potential schemes list for consideration at the next meeting of the Panel.
 - Councillor Mrs P A Channer raised the issue of safety on the footway near to Lidl due to HGVs being in the area. The Highways Liaison Officer would add this to the potential schemes list for consideration at the next meeting of the Panel.
 - Councillor R Pratt requested that Old Heath Road, Southminster be added to the potential schemes list with a request that it should be made a quiet road.

The Chairman requested that Officers should be advised of any requests by Members of the Panel prior to meetings of the Panel. This would give Officers the opportunity to give some consideration to requests prior to the meeting taking place.

In response to a request regarding a broken lamppost, the Highways Liaison Manager reminded Members of the Panel that this did not fall within the remit of the Panel. Such matters were maintenance issues which was a completely separate division to the Local Area Highways Panels. Members should raise these issues formally with the County Councillor for that division.

(ii) Local Area Highways Panel Terms of Reference

The Chairman advised Members of the Panel that the Local Area Highways Panels Terms of Reference had been published on the Essex County Council website. Following a request, it was agreed that the Highways Liaison Officer would circulate this to Members of the Panel by email.

The Highways Liaison Manager confirmed that she would also arrange for the link to the Members' Guide, which was currently being drafted, to be emailed

to Members of the Panel. This gave guidance as to the process of requesting schemes to be put to the Panel.

MALDON DISTRICT LOCAL HIGHWAYS PANEL POTENTIAL SCHEMES LIST (Version 22)

As part of the Essex County Council 2017/18 budget it is believed that the Capital budget for the Maldon District Local Highways Panels (LHP) will remain the same as that for 2016/17. This would mean for Maldon District LHP the available 2017/18 capital budget would be £200,000. It is recommended for 2017/18 that the Panel make further scheme funding recommendations to create a £280,000 rolling programme of highway improvement works.

This Potential Scheme List identifies all of the scheme requests which have been received for the consideration of the Maldon District Local Highways Panel.
