## Footpath 3 Tendring

A part length of Footpath 3 Tendring of unknown width shown by a bold continuous line on the order map commencing from the point where it connects to Wolves Hall Lane running between farm buildings then across a field in a south south westerly direction for a distance of 536 metres to the point in the field where it connects to Footpath 8 Tendring then continuing across the field in a south south westerly direction for a final distance of 198 metres to a point at the field edge by the corner of a wooded area, to an alternative route 2 metres in width shown by a bold broken line on the order map commencing from a point where it meets Wolves Hall Lane 350 metres west of the aforementioned start point running in a south westerly direction along a field edge on the western side of the field boundary for a distance of 260 metres to a point at the field boundary over a newly installed ditch crossing then continues across a grassed area along the field edge on the eastern side of the field boundary for a further distance of 250 metres to the point where it connects to the diverted route of Footpath 8 Tendring. The path then continues along the field edge for a final distance of 170 metres to the aforementioned endpoint where it continues unaffected.

## Footpath 8 Tendring

i) A part length of Footpath 8 Tendring of unknown width shown by a bold continuous line on the order map commencing from the point where it leaves the field edge running across a field and through a wooded area for a total distance of 312 metres to a point at the field edge, to an alternative route 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned start point running in an east north easterly direction along the field edge for a total distance of 215 metres to the aforementioned connection point to the diverted route of Footpath 3 via a new ditch crossing.

ii) A further section of Footpath 8 Tendring commencing from the point where it connects to Lodge Lane running in a north easterly direction between farm buildings then in a generally south easterly direction along a field edge and through a wooded area for a total distance of 620 metres to a point at the field edge by a wooded area, to an alternative route 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned start point running in a south easterly direction along a track for a total distance of 302 metres to the point where the track connects to the field edge where it continues unaffected.

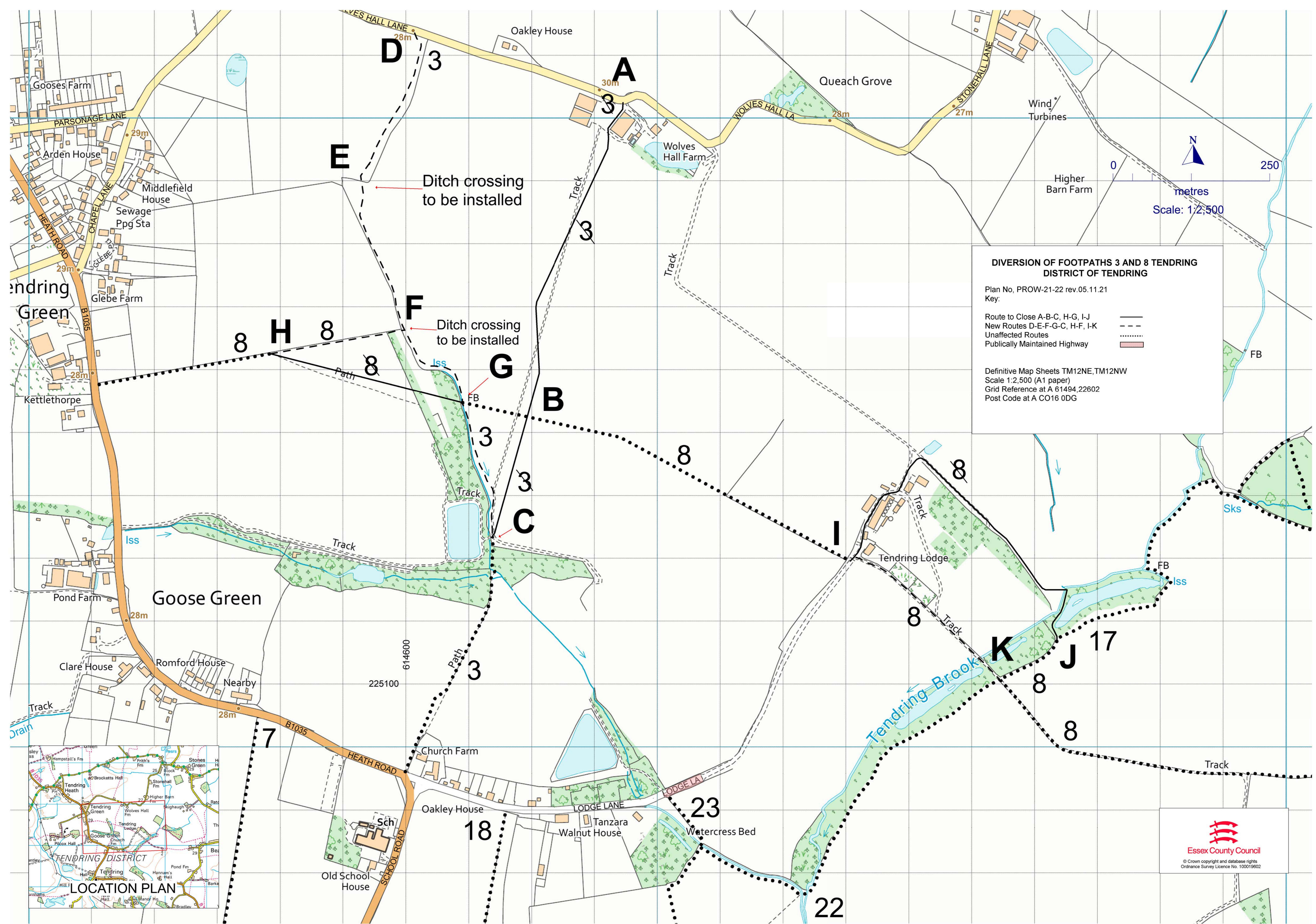

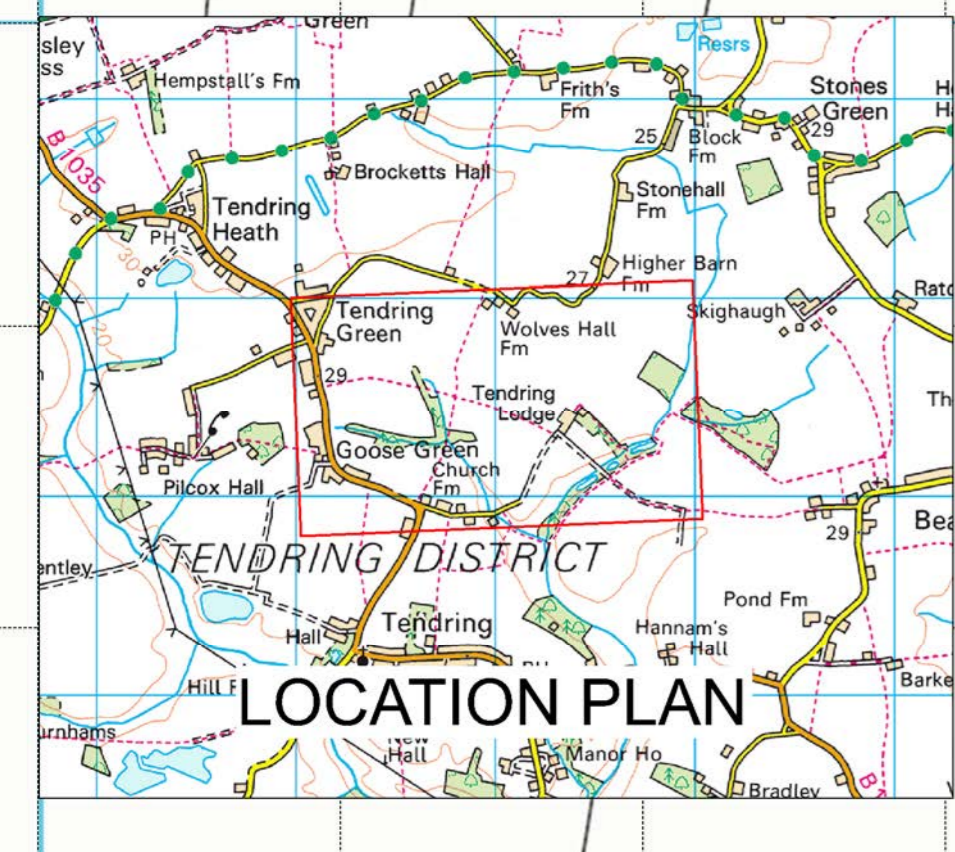

The above order, made on 2 February 2022 under section 119 of the Highways Act 1980, as shown on the order maps will divert:

#### Footpath 3 Tendring

A part length of Footpath 3 Tendring of unknown width shown by a bold continuous line on the order map commencing from the point where it connects to Wolves Hall Lane running between farm buildings then across a field in a south south westerly direction for a distance of 536 metres to the point in the field where it connects to Footpath 8 Tendring then continuing across the field in a south south westerly direction for a final distance of 198 metres to a point at the field edge by the corner of a wooded area, to an alternative route 2 metres in width shown by a bold broken line on the order map commencing from a point where it meets Wolves Hall Lane 350 metres west of the aforementioned start point running in a south westerly direction along a field edge on the western side of the field boundary for a distance of 260 metres to a point at the field boundary over a newly installed ditch crossing then continues across a grassed area along the field edge on the eastern side of the field boundary for a further distance of 250 metres to the point where it connects to the diverted route of Footpath 8 Tendring. The path then continues along the field edge for a final distance of 170 metres to the aforementioned endpoint where it continues unaffected.

#### Footpath 8 Tendring

- i) A part length of Footpath 8 Tendring of unknown width shown by a bold continuous line on the order map commencing from the point where it leaves the field edge running across a field and through a wooded area for a total distance of 312 metres to a point at the field edge, to an alternative route 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned start point running in an east north easterly direction along the field edge for a total distance of 215 metres to the aforementioned connection point to the diverted route of Footpath 3 via a new ditch crossing.
- ii) A further section of Footpath 8 Tendring commencing from the point where it connects to Lodge Lane running in a north easterly direction between farm buildings then in a generally south easterly direction along a field edge and through a wooded area for a total distance of 620 metres to a point at the field edge by a wooded area, to an alternative route 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned start point running in a south easterly direction along a track for a total distance of 302 metres to the point where the track connects to the field edge where it continues unaffected.

### (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.20) Order 202\*

**Notice is hereby given** that the Essex County Council intends to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended), and Schedule 1 of The Traffic Orders Procedures Regulations 1996.

**Effect of the order:** To Introduce No Waiting at Any Time Restrictions on the following lengths of road in the District of Tendring.

### (Artillery Street, Colchester) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Artillery Street, Colchester in the Borough of Colchester, from its junction with Victor Road to its junction with New Park Street a distance of approximately 30m. The closure is scheduled to commence on 14th March 2022 for 3 days, or where stated on a valid permit (AD01459858572 – Anglian Water). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while hydrant installation works are undertaken by Anglian Water.

An alternative route is available via Port Lane, Barrack Street, Artillery Street and vice versa. The Order will come into effect on 24th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Cage Lane, Boxted) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Cage Lane, Boxted in the Borough of Colchester, from a point approximately 150m south east of its junction with Dedham Road for a distance of approximately 105m in a south easterly direction. The closure is scheduled to commence on 14th March 2022 for 3 days, or where stated on a valid permit (BC411SAWCQL75H002 – Openreach). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while duct laying works are undertaken by Openreach.

### (Colchester Road/Chelmsford Road & Brentwood Road, Holland on Sea) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

#### Effect of the order:

- To temporarily close that length of Colchester Road, Holland on Sea in the District of Tendring, from its junction with Ipswich Road for a distance of approximately 50m in a south westerly direction.
- To temporarily close that length of Chelmsford Road, Holland on Sea in the District of Tendring, from its junction with Ipswich Road for a distance of approximately 50m in a south westerly direction.

### (Colchester Road, St. Osyth) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Colchester Road, St. Osyth in the District of Tendring, from a point approximately 60m north of the junction with Clacton Road for a distance of approximately 45m in a northerly direction. The closure is scheduled to commence on 20th March 2022 for 1 day, or where stated on a valid permit (ZY006511275 – E S Pipelines Ltd). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while new connection works are undertaken by E S Pipelines Ltd.

### (Connaught Avenue, Frinton on Sea) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Connaught Avenue, Frinton on Sea in the District of Tendring, from its junction with Frinton Road to its junction with Pole Barn Lane a distance of approximately 60m. The closure is scheduled to commence on 19th March 2022 for 2 nights (23:59 – 08:10), or where stated on a valid permit (KL701TWN-69-44-190322 – Network Rail Infrastructure Ltd). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while inspection works are undertaken by Network Rail Infrastructure Ltd.

### (Grange Road, Tiptree) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

### (Godmans Lane, Marks Tey) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Godmans Lane, Marks Tey in the Borough of Colchester, from its junction with Jays Lane for a distance of approximately 480m in a westerly then north westerly direction. The closure is scheduled to commence on 3rd March 2022 for 6 days, or where stated on a valid permit (EP201EH2325807 – Essex County Council). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while carriageway patching works are undertaken by Essex County Council.

The Order will come into effect on 24th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Ipswich Road, Holland on Sea) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Ipswich Road, Holland on Sea in the District of Tendring, from its junction with Brentwood Road to its junction with Frinton Road a distance of approximately 230m. The closure is scheduled to commence on 14th March 2022 for 19 days, or where stated on a valid permit (AZ5011001112082 – Cadent). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while mains replacement works are undertaken by Cadent.

An alternative route is available via Frinton Road, Windermere Road, Brentwood Road, Ipswich Road and vice versa.

The Order will come into effect on 24th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Jubilee Lane, Ardleigh) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Jubilee Lane, Ardleigh in the District of Tendring, from a point approximately 120m south east of its junction with Spring Valley Lane for a distance of approximately 230m in a south easterly then southerly direction. The closure is scheduled to commence on 14th March 2022 for 5 days, or where stated on a valid permit (EC30076279957 – UK Power Networks). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while new connection works are undertaken by UK Power Networks.

An alternative route is available via Bromley Road, Spring Valley Lane and vice versa.

The Order will come into effect on 24th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Mersea Avenue, West Mersea) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Mersea Avenue, West Mersea in the Borough of Colchester, from its junction with St Peters Road to its junction with High Street North a distance of approximately 355m. The closure is scheduled to commence on 9th March 2022 for 3 days, or where stated on a valid permit (EP201EH2325617 – Essex County Council). The Order will come into effect on 24th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Tower Road, Clacton on Sea) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Tower Road, Clacton on Sea in the District of Tendring, from its junction with Freeland Road to its junction with Beatrice Road a distance of approximately 90m. The closure is scheduled to commence on 21st March 2022 for 3 days, or where stated on a valid permit (EP201EH2326218 – Essex County Council). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while carriageway patching works are undertaken by Essex County Council.

An alternative route is available via Freeland Road, Wash Lane, Arnold Road, Beatrice Road and vice versa.

The Order will come into effect on 24th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Brighton Road, Holland on Sea) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council has made the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Brighton Road, Holland on Sea in the District of Tendring, from its junction with Frinton Road to its junction with Kings Parade a distance of approximately 310m. The closure is scheduled to commence on 28th February 2022 for 26 days, or where stated on a valid permit (AZ5011001120654 – Cadent). The scheduled dates may vary for these works with appropriate signs showing and/or displayed on one.network. The closure is required for the safety of the public and workforce while mains replacement works are undertaken by Cadent.

An alternative route is available via Frinton Road, Frinton Road Roundabout, Kings Parade and vice versa.

The Order came into effect on 10th February 2022 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

### (Carters Hill, Boxted) (Temporary Prohibition of Traffic) Order 2022

**Notice is hereby given** that the Essex County Council has made the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

**Effect of the order:** To temporarily close that length of Carters Hill, Boxted in the Borough of Colchester, from a point approximately 160m south west of its junction with Cooks Hill for a distance of approximately 265m in a south westerly then south easterly direction. The closure is scheduled to commence on 1st March 2022 for 1 day, or where stated on a valid permit (BC008PTMS114751 – Openreach). The closure is required for the safety of the public and workforce while pole testing works are undertaken by Openreach.

### (Fishponds Hill, Great/Little Horkesley) (Temporary Prohibition of Traffic) Order 2022

**Effect of the order:** To temporarily close that length of Fishponds Hill, Great/Little Horkesley in the Borough of Colchester, from the junction with London Road to the junction with Water Lane a distance of approximately 765m.
