This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The Applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Braintree District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

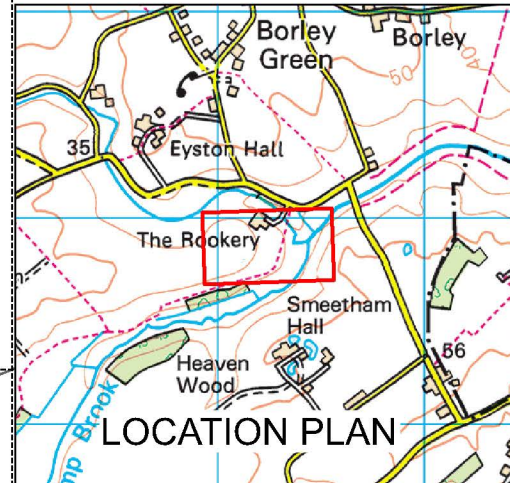
- 1) The public right of way over the land situated south of Belchamp Walter Road known as Footpath 7 Belchamp Walter in the District of Braintree and shown by a bold continuous line on the order map numbered PROW-23-08 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.

- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of Belchamp Walter Road known as Footpath 7 Belchamp Walter in the District of Braintree as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-08 contained in this order.

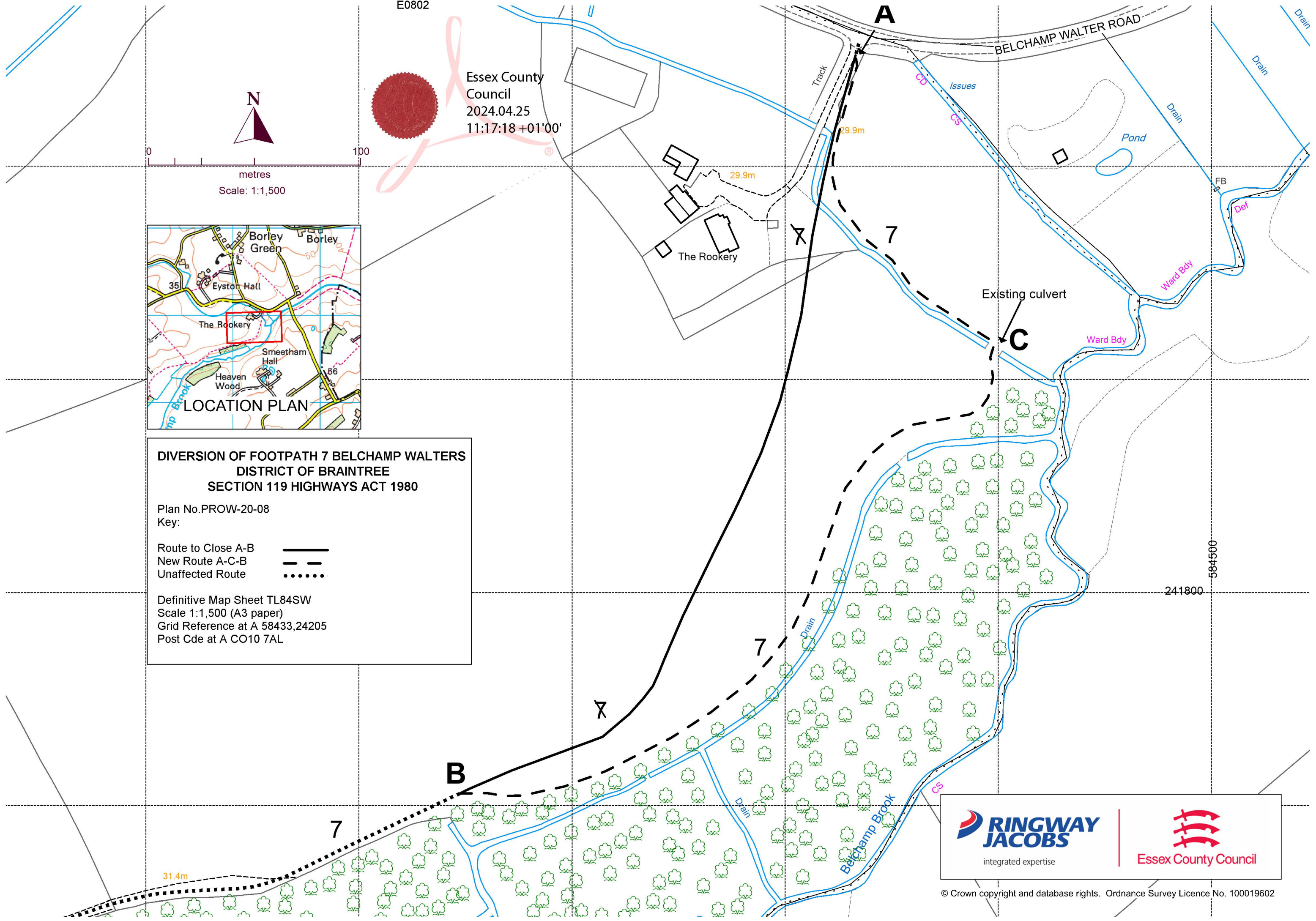
**DIVERSION OF FOOTPATH 7 BELCHAMP WALTERS

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 7 Belchamp Walter of unknown width shown by a bold continuous line on the order map commencing at point **A** at grid reference 58433,24205 running in a southerly direction from Belchamp Walter Road along a field edge to where it crosses a watercourse and through a private garden belonging to The Rookery then continuing across an agricultural field in a southerly then south westerly direction for a total distance of approximately 423 metres to point **B** at grid reference 58414,24170 where it continues unaffected.


DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a southerly then south easterly direction for a distance of approximately 176 metres to point **C** at grid reference 58439,24191 where it crosses an existing culvert over the aforementioned watercourse then continues in a southerly then south westerly direction following the field edge approximately 10 metres away from the edge of the watercourse for a final distance of approximately 364 metres to the aforementioned point **B** where it continues unaffected.


