This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

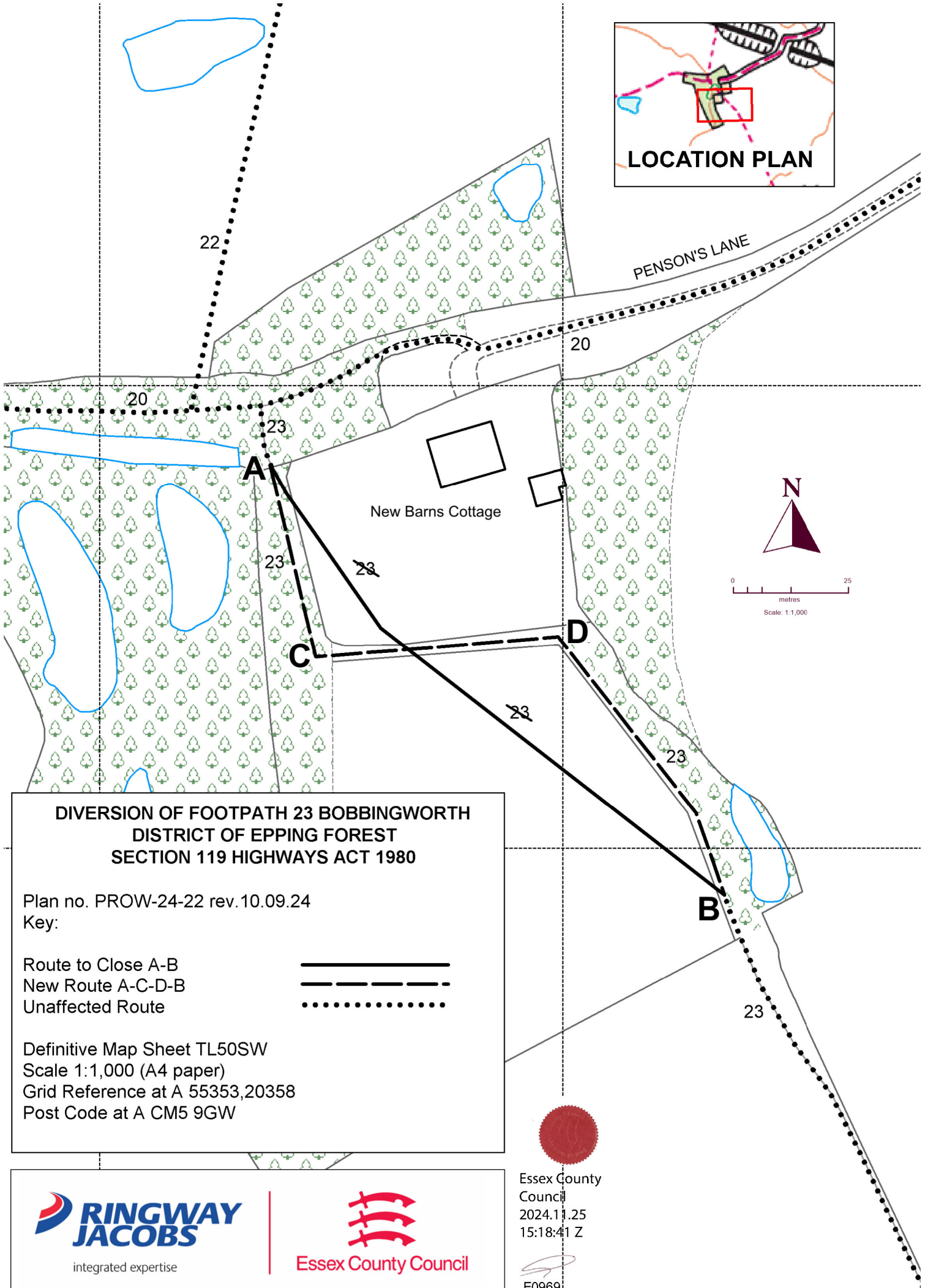
The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:




1) The public right of way over the land situated south of Bridleway 20 Bobbingworth/Penson’s Lane known as Footpath 23 Bobbingworth in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-24-22 rev.10.09.24 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.

2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of Bridleway 20 Bobbingworth/Penson’s Lane known as Footpath 23 Bobbingworth in the District of Epping Forest as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-24-22 rev.10.09.24 contained in this order.

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 23 Bobbingworth of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55353,20358 located in a wooded area close to the north west boundary of the property known as New Barns Cottage running in a south easterly direction through a garden and then a paddock area for a total distance of approximately 135 metres to point **B** at grid reference 55363,20348 on a path adjacent to the paddock area where it continues unaffected.


(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a generally southerly direction between a wooded area and the garden fence for a distance of approximately 42 metres to point **C** at grid reference 55354,20354 at the south westerly corner of the garden boundary then continuing in a generally westerly direction between the garden and paddock areas for a further distance of approximately 52 metres to point **D** at grid reference 55359, 20354. The path then continues along a path on the western side of the paddock area for a final distance of approximately 67 metres to the aforementioned point **B** where it continues unaffected.


