**NOTICE OF CONFIRMATION OF AN ORDER**  
**TOWN & COUNTRY PLANNING ACT SECTION 257**  
**FOOTPATH 8 BOREHAM**  
**PUBLIC PATH DIVERSION ORDER 2021**

The above Order, confirmed on 24 August, 2021 under section 257 of the Town & Country Planning Act 1990 will divert a part length of Footpath 8 in the parish of Boreham.

Chelmsford City Council Planning granted Beaulieu Outline Planning Permission (Ref:09/01314/EIA) Dated 7 March 2014 and Radial Distributor Road (Phase 2B) (REF: 17/02039/REM) Dated 27 April 2018, which necessitate the re-routing of the footpath.

A part length of Footpath 8 Boreham commencing from a point 25 metres north east of Park Farm Cottage running in a north easterly direction for a distance of 95 metres to a point where it continues unaffected, to an alternative route 3.5 metres in width commencing at the aforementioned start point running in a generally north easterly then north, north westerly then generally north, north easterly direction for a distance of 97 metres to a point where it then continues in a south easterly direction for a distance of 49 metres to the aforementioned end point where it continues unaffected.

This Order comes into force on the date on which Essex County Council on behalf of Chelmsford City Council certify that the terms of Article 2 of the Order have been complied with but if a person aggrieved by the order wants to question its validity or that of any provision contained in it on the ground that it is not within the powers of the Act, or on the ground that any requirement of the Act or of any regulation made under it has not been complied with in relation to the confirmation of the Order, he or she may apply to the High Court for any of these purposes under section 287 of the Town and Country Planning Act 1990 within 6 weeks from 30 September 2021 on which notice is first published as required by paragraph 8 of Schedule 14 to that Act.
