This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owners of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

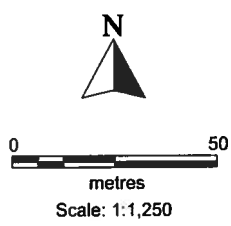
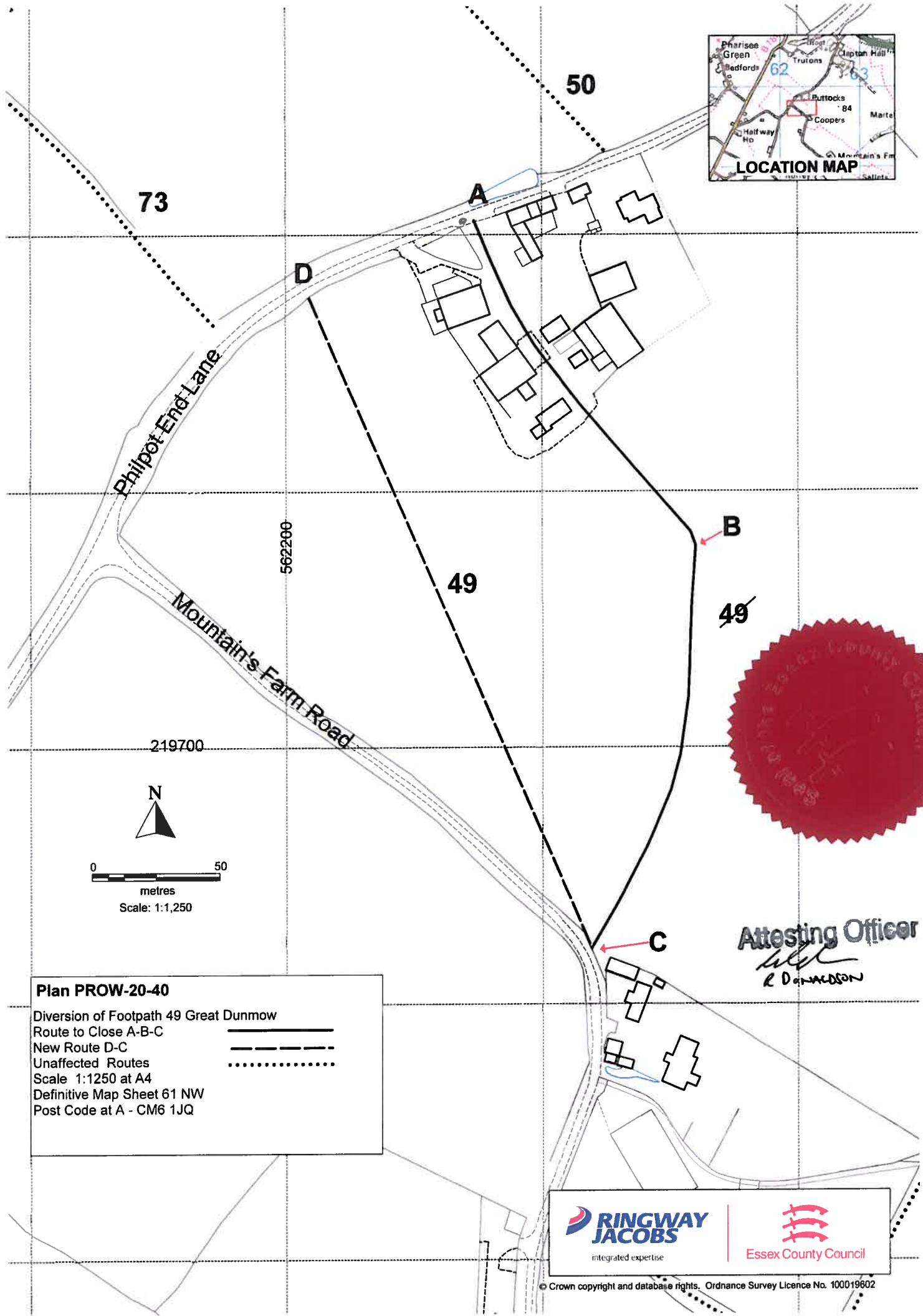
The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public will be split with Essex County Council.

Uttlesford District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1) The public right of way over the land situated at Puttocks Farm known as Footpath 49 Great Dunmow in the District of Uttlesford and shown by a bold continuous black line on the order map numbered PROW 20-40 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.

2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated west of Puttocks Farm known as Footpath 49 Great Dunmow in the District of Uttlesford as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered PROW 20-40 contained in this order.

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The entire length of Footpath 49 Great Dunmow of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 56227 21990 on Philpot End Lane running in a generally south south easterly direction for a distance of approximately 155 metres to point **B** at grid reference 56236 21978 then continuing in a southerly then south south westerly direction for a final distance of approximately 164metres to point **C** at grid reference 56232 21962 where it meets Mountain's Farm Road.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing at point **D** at grid reference 56221 21988 on Philpot End Lane running in a generally south south easterly direction for a total distance of approximately 276 metres to the aforementioned point **C**.
