This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Brentwood Borough Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

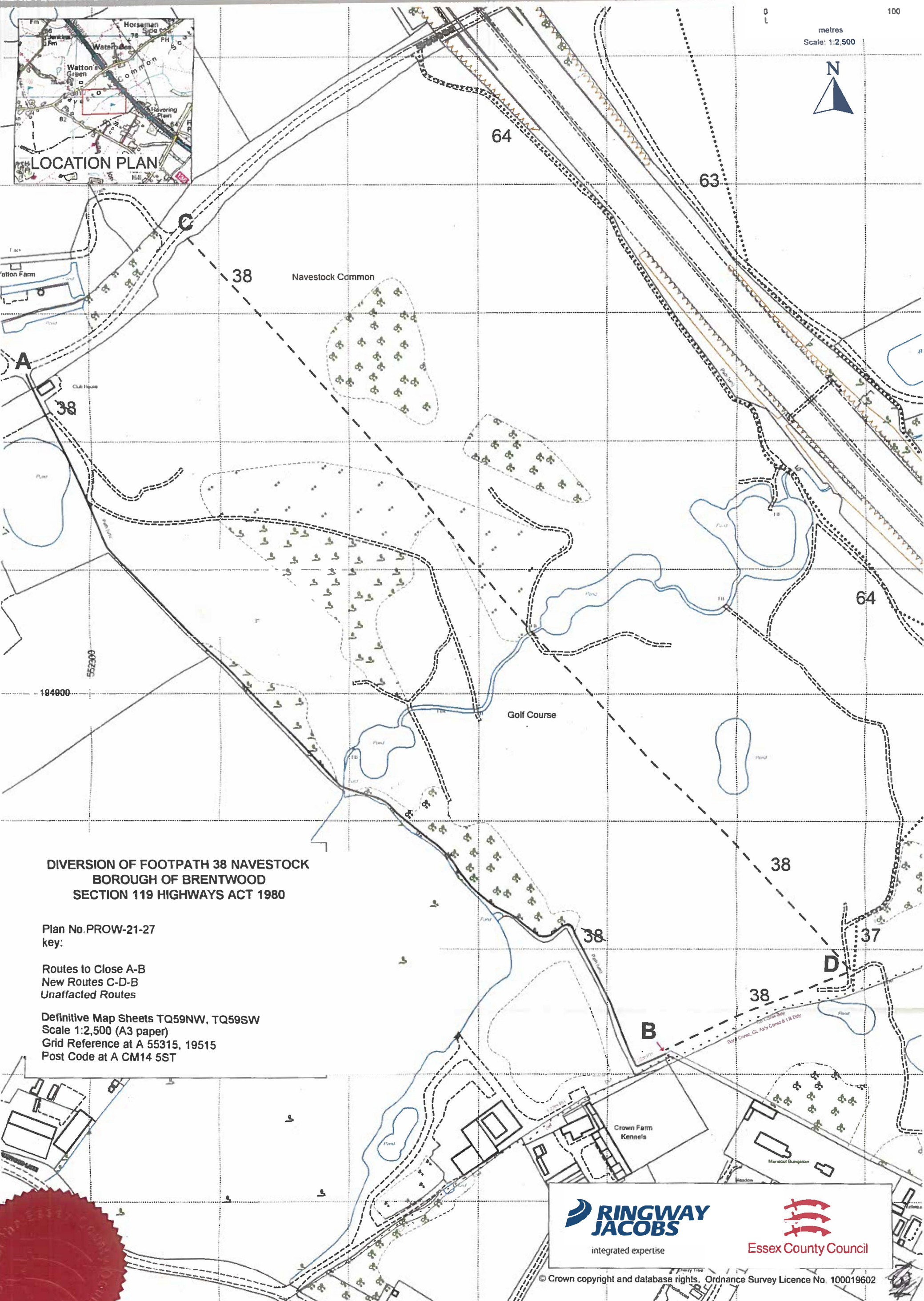
**BY THIS ORDER:**

- 1) The public right of way over the land situated south of Horseman Side known as Footpath 38 Navestock in the Borough of Brentwood and shown by a bold continuous line on the order map numbered PROW-21-27 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of Horseman Side known as Footpath 38 Navestock in the Borough of Brentwood as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-21-27 contained in this order.

**SCHEDULE**

**(PART 1)**

**DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

A part length of Footpath 38 Navestock of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55315,19515 located by Horseman Side running in a generally south easterly then north easterly then south easterly and then finally north easterly direction across a former golf course for a total distance of approximately 783 metres to point **B** at grid reference 55364,19462 approximately 7 metres north of the administrative boundary of the London Borough of Havering where it continues unaffected.

**(PART 2)**

**DESCRIPTION OF SITE OF NEW PATH OR WAY**

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at point **B** at grid reference 55327,19526 located approximately 163 metres north east of the aforementioned point **A** running in a south easterly direction across the former golf course for a distance of approximately 770 metres to point **D** at grid reference 55379, 19648 where it connects to Footpath 37 Navestock then continues in a south westerly direction across the former golf course for a final distance of approximately 157 metres to the aforementioned point **B** where it continues unaffected.
