
This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the bridleway described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

The applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and to defray any expenses incurred in the order making and bringing the new site of the way into a fit condition for use by the public.

Uttlesford District Council have been consulted.

BY THIS ORDER:

- 1) The public right of way over the land situated south and east of Stocking Green Farm known as Bridleway 4 Radwinter in the District of Uttlesford and shown by a bold continuous line on the order map numbered PROW-21-30 rev.26.07.22 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public bridleway over land situated south and east of Stocking Green Farm known as Bridleway 4 Radwinter in the District of Uttlesford as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-21-30 rev.26.07.22 contained in this order.



SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING WAY

A part length of Bridleway 47 Radwinter of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55922,23840 where it connects to Bridleway 103 Radwinter and the unnamed road to Stocking Green Farm running in an east north easterly then south easterly direction along a driveway through a garden continuing across a small section of field and along a field edge for a distance of approximately 224 metres to point **B** at grid reference 55942,23835 where it connects to Footpath 52. The way then continues in a north easterly direction across a field for a final distance of approximately 270 metres to point **C** at grid reference 55961,23852 at the corner of a headland where it continues unaffected.

(PART 2)

DESCRIPTION OF SITE OF NEW WAY

A bridleway being 3 metres in width shown by a bold broken line on the order map commencing at point **D** at grid reference 55929,23857 just north of the north western boundary of Stocking Green Farm where it connects to Footpath 48 Radwinter running west along the field edge on the northern side of a field boundary for a distance of approximately 258 metres to point **E** at grid reference 55955,23858 then continuing first in a southerly then westerly then south westerly direction crossing the ditch by a culvert and then along the field edge for a final distance of approximately 96 metres to the aforementioned point **C** where it continues unaffected.
