### NOTICE OF CONFIRMATION OF AN ORDER HIGHWAYS ACT 1980 ESSEX COUNTY COUNCIL PUBLIC PATH DIVERSION ORDER 2023 BRIDLEWAY 47 RADWINTER

On 2 November Essex County Council confirmed the above order made under section 119 of the Highways Act 1980. The effect of the order as confirmed as shown on the order map is to divert a part length of Bridleway 47 Radwinter commencing from a point where it connects to Bridleway 103 Radwinter and the unnamed road to Stocking Green Farm running in an east north easterly then south easterly direction along a driveway through a garden continuing across a small section of field and along a field edge for a distance of 224 metres to the point where it connects to Footpath 52. The way then continues in a north easterly direction across a field for a final distance of 270 metres to a point at the corner of a headland, to an alternative route 3 meters in width commencing from a point just north of the north western boundary of Stocking Green Farm where it connects to Footpath 48 Radwinter running west along the field edge on the northern side of a field boundary for a distance of 258 metres to a point close to the eastern boundary of the field then continuing first in a southerly then westerly then south westerly direction crossing the ditch by a culvert and then along the field edge for a final distance of 96 metres to the aforementioned end point where it continues unaffected.

## CREATION OF A FOOTPATH AT RADWINTER IN THE DISTRICT OF UTTLESFORD PUBLIC PATH CREATION ORDER 2023

On 2 November Essex County Council confirmed the above order made under section 26 of the Highways Act 1980. The effect of the order as confirmed as shown on the order map will create a length of footpath being 2 metres in width commencing at the point where it meets Bridleway 103 Radwinter and the unnamed road to Stocking Green Farm running first in an east south easterly then south easterly direction along a field edge across a field then along a further field edge for a total distance of 211 metres to the point where it connects to Footpath 52 Radwinter.

## BRIDLEWAY UPGRADE OF FOOTPATH AT RADWINTER IN THE DISTRICT OF UTTLESFORD PUBLIC PATH CREATION ORDER 2023

On 2 November Essex County Council confirmed the above order made under section 26 of the Highways Act 1980. The effect of the order as confirmed as shown on the order map will create a length of public bridleway being 3 metres in width commencing at the point where it meets Bridleway 103 Radwinter running in a north easterly direction along a track for a total distance of 135 metres to the point where it connects to the diverted route of Bridleway 47 Radwinter and the onward continuation of Footpath 48. The bridleway is an upgrade of part of the existing Footpath 48 Radwinter.

The alternative route for Bridleway 47 and the new section of footpath and bridleway come into force on 30 November 2023, and the old route of bridleway 47 shall be stopped up with effect from 7 December 2023, but if a person aggrieved by the orders wants to question their validity, or that of any provision contained in them, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Orders, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 9 November 2023 make an application to the High Court.
