**NOTICE OF CONFIRMATION OF AN ORDER  
HIGHWAYS ACT 1980  
ESSEX COUNTY COUNCIL  
PUBLIC PATH DIVERSION ORDER 2021  
FOOTPATHS 16, 17 AND 18 RADWINTER**

On 29 October 2021 Essex County Council confirmed the above order made under section 119 of the Highways Act 1980. The effect of the order as confirmed as shown on the order map is to divert:

## Footpath 16 Radwinter

The entire length of Footpath 16 of unknown width commencing from a point at the south eastern corner of the woods running in a north westerly direction across a field for a distance of 103 metres to a point at the edge of the woods continuing in a west north westerly, then west south westerly and finally north westerly direction for a distance of 297 metres across a field and through a garden area to the point where it connects to Footpath 15, to an alternative route 2 metres in width commencing at the aforementioned start point running in a generally north westerly direction for a distance of 107 metres through a grassed area in an arc north of the existing route to the aforementioned point at the edge of the woods where it runs in a generally north westerly direction for a distance of 316 metres around the perimeter of the woods to a point where it connects to Footpath 15 246 metres north of its current connection point.

## Footpath 17

A part length of Footpath 17 of unknown width commencing from a point east of Water Lane north of a footbridge running in an east north easterly direction for a distance of 463 metres across a field to the aforementioned start point for Footpath 16 where it continues unaffected, to an alternative route 2 metres in width commencing at the aforementioned start point running in generally southerly direction for a distance of 193 metres along the field edge to a point in the south western corner of a field where it continues in a north easterly direction along the field edge to a point where it connects to the current route of Footpath 18 before heading in a south easterly direction for a distance of 6 metres to cross the field boundary to the point where it connects to Footpath 18 on the western side of the field boundary.

## Footpath 18

A part length of Footpath 18 of unknown width commencing from the point where it connects to the aforementioned proposed diversion route for Footpath 17 running in a north easterly direction for a distance of 320 metres to the aforementioned point at the south eastern corner of the woods where it connects to Footpaths 16 and 17, to an alternative route 2 metres in width commencing at the aforementioned point on the western side of the field boundary running in a north easterly direction for a distance of 279 metres at the field edge on the south side of a field boundary to the point where it connects to footpath 20.

The alternative route comes into force on 26 November 2021, and the old route shall be stopped up with effect from 3 December 2021, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 11 November 2021 make an application to the High Court.
