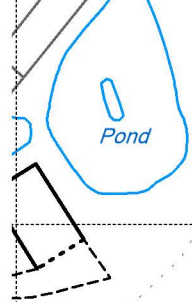
This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the applicant of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The Applicant (Environment Agency) has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated north of Shonks Mill Road known as Footpath 47 Stanford Rivers in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-22-34 rev. 17.01.23 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated north of Shonks Mill Road known as Footpath 47 Stanford Rivers in the District of Epping Forest as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-22-34 rev. 17.01.23 contained in this order.

## **SCHEDULE**

### **(PART 1)**

#### **DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

A part length of Footpath 47 of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55279,19823 at a point just north of Shonks Mill Lane running in a generally north westerly then generally north north easterly direction across a field for a total distance of approximately 343 metres to point **B** at grid reference 55270,19854 where it continues unaffected.

### **(PART 2)**


#### **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a generally north north easterly direction across a field for a distance of approximately 41 metres to point **C** at grid reference 55281,19825 where it approaches the site of a proposed embankment dam and continues in first a west north westerly then generally north westerly direction across a field and parallel to the foot of the proposed embankment dam for a further distance of approximately 316 metres to point **D** at grid reference 55260, 19846 close to the north west corner of the proposed embankment dam where the path continues in a north easterly direction across the field around the foot of the proposed structure for a final distance of approximately 131 metres to the aforementioned point **B** where it continues unaffected.
