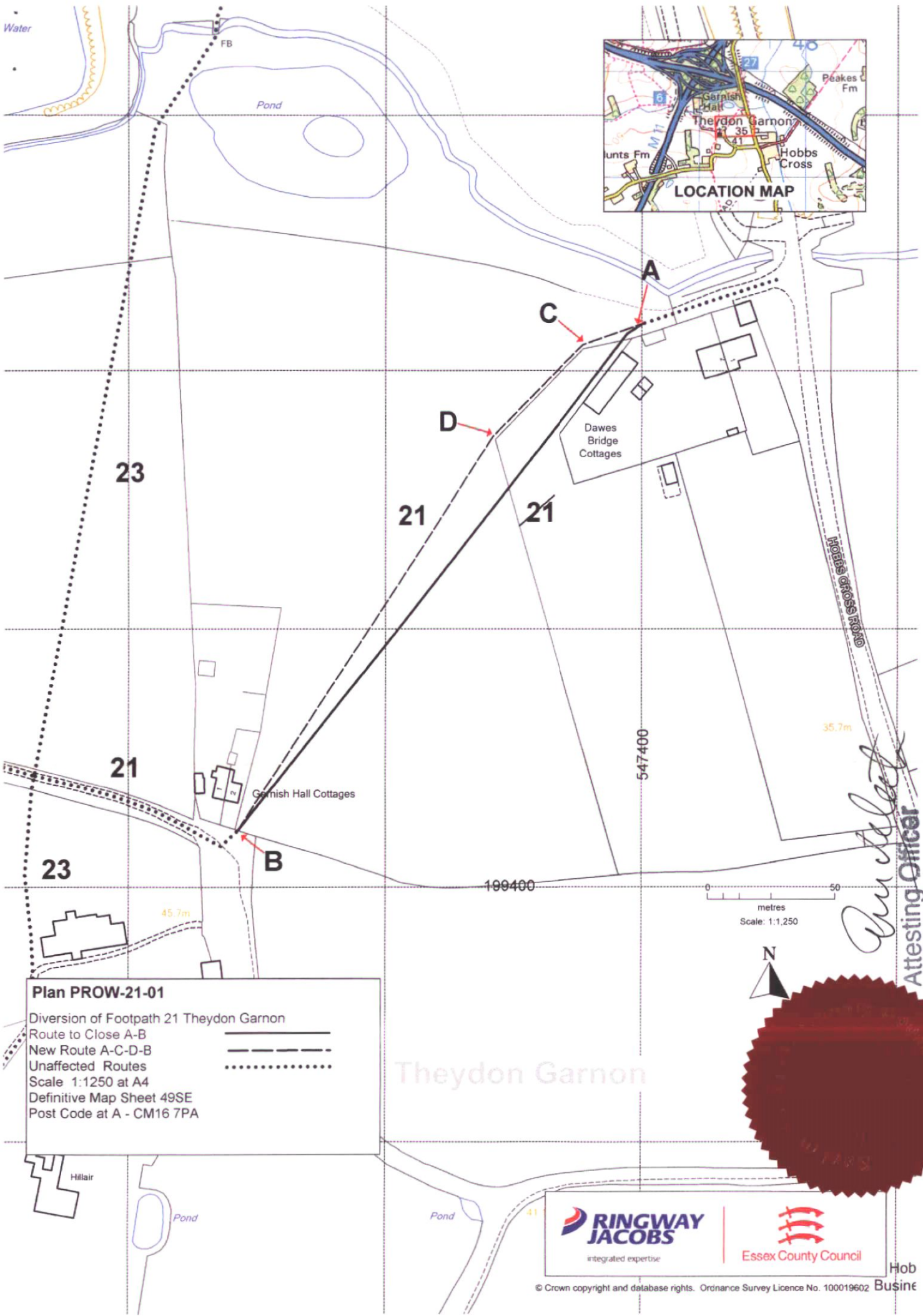
This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated west of Hobbs Cross Road known as Footpath 21 Theydon Garnon in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-21-01 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated west of Hobbs Cross Road known as Footpath 21 Theydon Garnon in the District of Epping Forest as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-21-01 contained in this order.

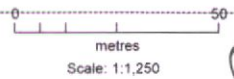


Plan PROW-21-01

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS

A part length of Footpath 21 Theydon Garnon of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 54740 19962 shortly after entering the field north of Dawes Bridge Cottages running in a south westerly direction across a fenced paddock then a field for a total distance of approximately 250 metres to point **B** at grid reference 54724 19942 on the field edge to the east of Garnish Hall Cottages.

(PART 2)

DESCRIPTION OF SITE OF NEW PATHS OR WAYS

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing at the aforementioned point **A** running in a west south westerly direction for a distance of approximately 24 metres to point **C** at grid reference 54738 19961 then continuing in a generally south westerly direction for a further distance of approximately 50 metres to point **D** at grid reference 54734 19957. The path then continues in a generally south westerly direction across the field for a final distance of approximately 180 metres (total distance of approximately 254 metres) to the aforementioned point **B**
