
This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Maldon District Council have been consulted as required by section 120(2) of the 1980 Act.

#### BY THIS ORDER:

- 1) The public right of way over the land situated west of Ulting Hall known as Footpath 7 Ulting in the District of Maldon and shown by a bold continuous line on the order map numbered PROW-24-02 rev.22.02.24 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated west of Ulting Hall known as Footpath 7 Ulting in the District of Maldon as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-24-02 rev.22.02.24 contained in this order.



#### SCHEDULE

## (PART 1)

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 7 Ulting of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 58086,20913 on the north side of a wooded area running in a south south easterly direction through the wooded area for a distance of approximately 88 metres to point **B** at grid reference 58087, 20904 at the southern end of the wooded area continuing in a westerly direction along the edge of the woods for a final distance of approximately 24 metres to point **C** at grid reference 58085,20905 where it continues unaffected.

#### (PART 2)

### DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a south westerly direction along a field edge north of the woods then through a small section of the woods for a distance of approximately 39 metres to point **D** at grid reference 58082,209118 where it continues in a south easterly direction on the eastern side of a ditch on a path located between the brow of the ditch and the woods for a final distance of approximately 72 metres to the aforementioned point **C** where it continues unaffected.
