**NOTICE OF CONFIRMATION OF AN ORDER
HIGHWAYS ACT 1980
ESSEX COUNTY COUNCIL
PUBLIC PATH DIVERSION ORDER 2022
FOOTPATHS 5, 4 AND 40 WEST HANNINGFIELD**

On 9 February 2022 Essex County Council confirmed the above orders made under section 119 of the Highways Act 1980. The effect of the orders as confirmed as shown on the order maps is to divert:

Footpath 5 West Hanningfield

(i) A part length of Footpath 5 West Hanningfield commencing from where it connects to the highway known as Bakers Lane running in a south easterly direction for a total distance of 160 metres to a point at the western boundary of a caravan park, to an alternative route 2 meters in width commencing from a point just north east of the existing start point running in a generally south easterly direction then a southerly direction for a total distance of 163 metres to the aforementioned end point where it continues unaffected.

(ii) A further part length of Footpath 5 West Hanningfield commencing from a point close to the western boundary of a caravan park running in a south easterly direction for a distance of 84 metres to a point within the caravan park then continuing in a west south westerly direction then a south, south westerly direction for a further distance of 111 metres to a point south west of the caravan park. The path then runs in an east north easterly direction for a final distance of 26 metres to a point at the south western boundary of the caravan park, to an alternative route 2 meters in width commencing from the aforementioned start point running in a generally south westerly direction then a south, south easterly direction for a distance of 84 metres to a point at the western edge of the caravan park then continuing in a south, south easterly direction for a final distance of 74 metres to the aforementioned end point where it continues unaffected.

Footpath 40 West Hanningfield

The entire length of Footpath 40 commencing from where it connects to Footpath 5 West Hanningfield running in a generally north easterly direction then a south easterly then finally in an easterly direction for a total distance of 240 metres to a point where it connects to Footpath 4 West Hanningfield, to an alternative route 2 meters in width commencing from a point by the access drive to the caravan park running in an east south easterly direction briefly then a northerly direction for a distance of 82 metres to a point where it will connect to the new route of Footpath 4.

Footpath 4 West Hanningfield

i) A part length of Footpath 4 commencing from point on the headland north of the caravan park running in a south easterly direction across the field for a total distance of 126 metres to a point at the north east boundary of the caravan park, to an alternative route 2 meters in width commencing from the aforementioned start point running in a generally southerly direction along the field boundary for a distance of 82 metres to the connection with the new route of Footpath 40 then continuing in an east north easterly direction along the field boundary for a final distance of 114 metres to the aforementioned end point where it continues unaffected.

ii) A further section of Footpath 4 commencing from a point close to the north eastern boundary of the caravan park running in a southerly direction on the west side of the property boundary of Little Peverels for a distance of 92 metres to a point by the access drive to Little Peverels then continuing in a south easterly direction for a final distance of 12 metres to a point by the access drive where it continues unaffected, to an alternative route 2 meters in width commencing from the aforementioned start point running in a generally southerly direction on the east side of the existing hedge for a total distance of 97 metres to the aforementioned end point where it continues unaffected.

The alternative routes come into force on 9 March 2022, and the old routes shall be stopped up with effect from 16 March 2022, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 7 April 2022 make an application to the High Court.
