**NOTICE OF MAKING OF AN ORDER  
HIGHWAYS ACT 1980  
ESSEX COUNTY COUNCIL  
PUBLIC PATH DIVERSION ORDER 2023  
FOOTPATHS 26 AND 27 WETHERSFIELD**

The above order, made on 20 March 2023, under section 119 of the Highways Act 1980, will divert a part length of Footpath 26 Wethersfield which has a part unknown and part minimum 4 feet width shown by a bold continuous line on the order map commencing from a point on the north side of a field boundary running in first a southerly then south westerly direction across a field for a distance of 209 metres to the point where it connects to and continues as Footpath 27 in a north westerly direction across a field through field boundaries and across the corner of another field for a further distance of 102 metres to the point where it connects to a track and continues unaffected, to an alternative route 2 meters in width commencing at the aforementioned start point running in a generally westerly direction along a track for a total distance of 260 metres to the aforementioned end point where it continues unaffected.

**PUBLIC PATH EXTINGUISHMENT ORDER 2023  
FOOTPATH 27 WETHERSFIELD**

The above order, made on 20 March 2023, under section 118 of the Highways Act 1980, will extinguish a part length of Footpath 27 Wethersfield of unknown width shown by a bold continuous line on the order map commencing from the point where it connects to Footpath 26 Wethersfield running in a south westerly direction between farm buildings and through a wall for a total distance of 273 metres to a point located to the south of farm buildings where it meets the end of the private access track known as Codham Little Park Drive.
