The Essex County Council (Brentwood District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.14) Order 20**

Notice is hereby given The Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984

Effect of the order: To introduce No Waiting at Any Time restrictions on the following lengths of road:

Whittington Road, Hutton

1)WEST SIDE: From a point approximately 88 metres from its junction with Fielding Way, on the western kerb line of Whittington Road, north, for approximately 14.3 metres. 2) WEST SIDE: from a point approximately 78 metres from its junction with Coran Green, on the western kerb line of Whittington Road, south, for approximately 8.6 metres. 3) WEST SIDE: From a point approximately 29 metres south of its junction with Coram Green, south for approximately 15 metres. 4) WEST SIDE: from a point approximately 19 metres from its junction with Coram Green north, for a distance of approximately 28 metres. 5) EAST SIDE: from a point approximately 6.06 metres from its junction with Carpenter Path south, for a distance of approximately 13 metres. 6) EAST SIDE: from a point approximately 9.60 metres from its junction with Coram Green south, for distance of approximately 15 metres. 7) WEST SIDE: from a point approximately 21 metres from its junction with the private road south, for a distance of approximately 28 metres. 8. WEST SIDE: from a point approximately 21 metres, from its junction with the private road north, for a distance of approximately 15 metres.

To relocate the existing advisory disabled parking bay outside number 98 Whittington Road, WEST SIDE: From a point approximately 88 metres from its junction with Fielding Way, on the western kerb line of Whittington Road to be incorporated into the parking bay area and marked accordingly and the allotted space either side of the disabled parking bay marked appropriately to ensure that the area is kept clear of any obstructions.

This Order will be incorporated into The Essex County Council (Brentwood Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 [hereinafter referred to as the 2019 Consolidation Order] by substituting tile numbers TQ625 952 Rev 1to Rev 2, TQ625 955 Rev 0 to Rev 1
