## The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.15) Order 202\*

**Notice is hereby given** that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

Watson Road,	NORTH-WEST SIDE: From the common boundary of property No. 5A
Clacton	& 7 Watson Road, south-westwards for approx. 6.6 metres
	Substitute Tile ref: TM170 150 revision 2 to 3
