

The Essex County Council (Various Byways, Delfits Lane, Uttlesford)
(Seasonal Prohibition of Motor Vehicles and Horse Drawn Vehicles)
Order 202*

The Essex County Council (“the Council”) in exercise of its powers under Sections 1(1) and (2), 2(1) to (3) and 3(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III to Schedule 9 to the Act, hereby makes the following Order:-

1. In this Order
“Motor vehicle” has the same meaning as in Section 136 of the Act.
2. This order shall come into operation onand may be cited as the Essex County Council (Byway 100, Wimbish; Byway 1, Little Henny, Byway 13, Middleton; Byway 61, Willingale (Lucas Lane); Byway 3, Pentlow and Hoe Lane) (Seasonal Prohibition of Driving) Order 20**.
3. Save as provided in Article 3 of this Order, no person shall cause any motor vehicle having more than two wheels or with two wheels abreast to proceed in that length of Byway as specified in the schedule to this Order, during the period 1 November to 31 March.
 - (a) is being used for conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to those lengths of byway.
 - (b) Is being used for the purpose of agriculture in connection with land adjacent to those byways or in connection with the conveyance or haulage of timber felled upon that land.
 - (c) Is being used for fire brigade, police or ambulance purposes.
 - (d) Is being used in connection with any of the following operations, namely: -
 - (i) building or demolition operations.
 - (ii) the removal of any obstruction to traffic.
 - (iii) the maintenance, improvement or reconstruction of those lengths of road.
 - (iv) the laying, erection, alteration or repair in or on land adjacent to those lengths of road, of any sewer, or main, pipe of apparatus for the supply of water, gas or electricity, or any telegraphic line; or
 - (e) is being used for the service of or contracted to local authority or water authority in pursuance of statutory powers or duties; or

- (f) Is to be garaged, serviced or repaired at any premises situated on or adjacent to those lengths of byway.
2. The Essex County Council (Byway 24, Broxted, Byway 99, Thaxted and Byway 22, Tilty, Delfits Lane, (Prohibition of Motor Vehicles and Horse Drawn Vehicles) Order 2019 is hereby revoked in so far as it relates to the lengths of Byway as specified in the Schedule to this Order. (Or, if the existing is only for these Byways, then, hereby revoked in its entirety).

The seasonal prohibition of driving will remain in force on Byway 100, Wimbish; Byway 1, Little Henny/Byway 13, Middleton; Byway 61, Willingale (Lucas Lane); Byway 3, Pentlow and Hoe Lane by virtue of this order.
