

# Public notice

The Essex County Council (A120, A1250 Dunmow Road, Birchanger Lane, Birchanger)  
(Restricted Road & 50MPH Speed Limit) Order 202\* and  
The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and  
Stopping) and (On-Street Parking Places) (Civil Enforcement Area)  
(Amendment No.15) Order 202\*

**Notice is hereby given** that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53, 81, 82(2), 83(2), 84(1) and (2) and Parts III & IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended), and Schedule 1 of The Traffic Orders Procedures Regulations 1996.

## Effect of the orders:

1. **To Introduce** a 50MPH Speed Limit on the following lengths of roads, Birchanger in the District of Uttlesford:

Road	Description
A120, Birchanger	<b>BOTH SIDES:</b> From a point approximately 68 metres northwest of its junction with the roundabout at Junction 8 of the M11, generally north west for a distance of approximately 600 metres.
A1250 Dunmow Road, Birchanger	<b>BOTH SIDES:</b> From its junction with the A120, southwest for a distance of approximately 295 metres.
Birchanger Lane, Birchanger	<b>BOTH SIDES:</b> From its junction with the A120, generally north for a distance of approximately 515 metres to its junction with Duck End and location of the existing restricted road restriction.

2. **To Introduce** a 24hour Clearway on the following length of roads, Birchanger in the District of Uttlesford:

Road	Description
A120, Birchanger	<b>BOTH SIDES:</b> From a point approximately 68 metres northwest of its junction with the roundabout at Junction 8 of the M11, generally north west for a distance of approximately 2067 metres.
A1250 Dunmow Road, Birchanger	<b>BOTH SIDES:</b> From its junction with the A120, southwest for a distance of approximately 305 metres.
Birchanger Lane, Birchanger	<b>BOTH SIDES:</b> From its junction with the A120, generally north for a distance of approximately 520 metres.

This Order will be incorporated into The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting tile numbers TL500 222, TL500 225, TL500 227, TL500 230, TL505 215, TL505 217, TL505 220, TL505 222, TL510 215, TL510 217, TL510 220 Revision 0 to Revision 1.

## Proposed Introduction and Conversion of Footway to Unsegregated Shared Footway/Cycleway – A120, A1250 Dunmow Road, Birchanger Lane, Birchanger Staggered Toucan Crossing - A120, Birchanger

**Notice is hereby given** that Essex County Council proposes to commence construction of shared unsegregated footway/cycleway at A120, A1250 Dunmow Road, Birchanger Lane, Birchanger in the District of Uttlesford under highway improvement powers given by Section 65 of the Highways Act 1980 and a Staggered Toucan Crossing under Sections 23 of the Road Traffic Regulation Act 1984 (as amended) on A120, Birchanger in the District of Uttlesford:

### Introduction of Shared unsegregated Footway/Cycleway – Width of 2.5 metres

Road	Description
A120, Birchanger	<b>NORTH SIDE:</b> From its junction with Birchanger Lane, west for a distance of approximately 20 metres. <b>SOUTH SIDE:</b> From its junction with A1250 Dunmow Road, east for a distance of approximately 15 metres.
Birchanger Lane, Birchanger	<b>WEST SIDE:</b> From its junction with A120, north for a distance of approximately 28 metres. <b>EAST SIDE:</b> From a point 29 metres north of its junction with the A120, north for a distance of approximately 18 metres.

### Conversion of existing footway to Shared unsegregated Footway/Cycleway – Width of 2.5 metres

Road	Description
A1250 Dunmow Road, Birchanger	<b>EAST SIDE:</b> From its junction with the A120, south west for a distance of approximately 145 metres.

### Staggered Toucan Crossing

Road	Description
A120, Birchanger	<b>SOUTH SIDE/EASTBOUND CARRIAGEWAY:</b> The centre line of the crossing is located approximately 15 metres east of its junction with A1250 Dunmow Road. <b>NORTH SIDE/WESTBOUND CARRIAGEWAY:</b> The centre line of the crossing is located approximately 20 metres west of its junction with Birchanger Lane
