

The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.49) Order 202*

The Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. This order shall come into operation on and may be cited as The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No 49) Order 202*

Effect of the order:

1. No Waiting At Any Time Restrictions in the City of Chelmsford as specified:

ROAD	DESCRIPTION
Maltings Road (Northern Arm)	BOTH SIDES: From the circulatory carriageway north for approximately 10 metres
Maltings Road (Eastern Arm)	BOTH SIDES: From the circulatory carriageway east for approximately 15 metres
Maltings Road (Southern Arm)	BOTH SIDES: From the circulatory carriageway south for approximately 10 metres
Maltings Road (Western Arm)	NORTH SIDE: From the circulatory carriageway west for approximately 15 metres
Maltings Road (Western Arm)	SOUTH SIDE: From the circulatory carriageway west for approximately 10 metres
Maltings Road Circulatory Carriageway	BOTH SIDES: The whole circulatory carriageway area fronting properties 13/15, 14/16, 53/55 & 54/56 Maltings Road including around the 'mini roundabout' itself

2. No Stopping At Any Time Except Buses (Bus Stop Markings) in the City of Chelmsford as specified:

ROAD	DESCRIPTION
Maltings Road (western arm)	NORTH SIDE: From a point approximately 17 metres south east from its junction with Park View Crescent in a south easterly direction for a distance of approximately 27 metres.
