

Public notice

The Essex County Council (Harlow District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No. 64) Order 202*

Notice is hereby given that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended).

Effect of the order:

1. To Upgrade (from Advisory to enforceable) Disabled Badge Holders Only

Road Name	Description
Abbotsweld	SOUTH SIDE: From a point in line with the western boundary of No's 248 and 247 Abbotsweld east for approximately 3 metres (Bay length 6 metres)
Abbotsweld,	SOUTH SIDE: From a point in line with the boundary of No's. 136 and 137 Abbotsweld, north east for approximately 5.5 metres.
Blackbush Spring	WEST SIDE: From a point in line with the boundary of No's of 81 and 82 Blackbush Spring, north for approximately 10 metres. (2 x 5 metre bays)
Chippingfield,	SOUTH SIDE: From a point in line with the boundary of No's. 44 and 46 Chippingfield, eastwards for approximately 5.5 metres.
Church Leys	EAST SIDE: From a point approximately 5.7 metres south from the centre of the junction with Church Leys (east west length), south eastwards for approximately 5.5 metres.
Fold Croft,	WEST SIDE: From a point in line with the boundary of No's. 215- and 216-Fold Croft, northwards for approximately 5.5 metres.
Joyners Field	NORTH SIDE: From a point approximately 2.2 metres north east of the boundary of No's. 11 and 12 Joyners Field, south west for approximately 5 metres.
The Hornbeams,	EAST SIDE: <ol style="list-style-type: none">From a point approximately 3.9 metres north of the boundary of No's. 194 and 195 The Hornbeams, north for approximately 4.0 metres (2 bays Width 2 metres x length 5 metres).From a point approximately 1.0 metre south of the boundary of No's. 191 and 192 The Hornbeams, south for approximately 2.5 metres.

2. To Revoke: 'Disabled Badge Holders Only' Bay

Road Name	Description
Barley Croft,	SOUTH SIDE: From a point in line with the boundary of No's. 46 and 47 Barley Croft, west for approximately 6 metres.
Long Ley	WEST SIDE: From a point in line with the boundary of No's. 33 and 34 Long Ley, north west for approximately 6.5 metres.

3. To Revoke: 'Disabled Badge Holders Only' Bay and To Implement: - 'Permit parking Area R Mon-Sat 8am-8pm'

Road Name	Description
Broadfield	NORTH SIDE: From a point in line with the boundary of No's. 53 and 54 Broadfield, south west for approximately 5 metres.

4. To Revoke: 'No Waiting Mon–Fri 10am–11am and **To Implement** Disabled badge Holders only'

Road Name	Description
Manor Road	EAST SIDE: From a point in line with the boundary of No's. 74 and 76 Manor Road, south for approximately 5.5 metres.
