**The Essex County Council (Various Roads, Alresford, and Elmstead)
(Combined Speed Limits) Order 202***
Toucan Crossing and Cycle Track – A133 Clacton Road, Elmstead

Notice is hereby given that the Essex County Council proposes to make the above Order under S81, 82(1) & (2)(b), 83(2), 84(1)(a) and (2), and Parts IV and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended)

Effect of the Order:

1. To Implement: a '30mph Speed Limit' (currently a 40mph Speed Limit)

Road	Description
A133 Clacton Road, Elmstead	From a point approximately 33 metres northwest of its junction with Winterbourne Gardens, southeast for approximately 175 metres.

2. To Implement: a '40mph Speed Limit' (currently a 60mph Speed Limit)

Road	Description
A133 Clacton Road, Elmstead	From a point approximately 141 metres southeast of its junction with Winterbourne Gardens, southeast for approximately 825 metres.

'The Essex County Council (Various Roads, Alresford, and Elmstead) (30mph Speed Limit and 40mph Speed Limit) Order 2024 is hereby revoked in its entirety. All restrictions shall continue in force by virtue of this new Order.

'The Essex County Council (Various Roads, Elmstead Market) (Restricted Roads & 40 MPH Speed Limit) Order 2019' is hereby revoked in its entirety. All restrictions shall continue in force by virtue of this new Order.

Notice is also hereby given that: Under Section 23 of the Road Traffic Regulations Act 1984 (as amended), Essex County Council proposes to establish a Toucan Crossing on the A133 Clacton Road, Elmstead, in the District of Tendring located as follows.

3. To Implement: a 'Toucan Crossing'.

Road	Description
A133 Clacton Road, Elmstead	The Centre Line of the crossing is located approximately 55 metres southeast of the junction with Broomfield Road, Elmstead. The width between give way lines is approximately 7.4 metres.

Zigzags for the above Zebra Crossing will be installed on the A133 Clacton Road approximately 17.5 metres either side of the zebra crossing, for the width of the road.

Under Section 65 of the Highways Act 1980, Essex County Council proposes to establish a 'Cycle Track', on the A133 Clacton Road, Elmstead, in the District of Tendring located as follows.

4. To Implement: a 'Cycle Track'.

Road	Description
A133 Clacton Road, Elmstead	Northeast Side: From a point approximately 118 metres northwest of its junction with Broomfield Road, southeast for approximately 213 metres.

	Southwest Side: From a point approximately 51 metres southeast of its junction with Broomfield Road, southeast for approximately 17 metres.
