

**The Essex County Council (Various Roads, Thorrington)  
(Combined Speed Limits) Order 202\***

The Essex County Council in exercise of its powers under Sections 81, 82(1) & (2)(b), 83(2), 84(1)(a) and (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour on the said length of road, in the Parish of Thorrington, in the District of Tendring as specified in Schedule 1 to this Order.
2. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on the said length of road, in the Parish of Thorrington, in the District of Tendring as specified in Schedule 2 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This order shall come into operation on ..... and may be cited as The Essex County Council (Various Roads, Thorrington) (Combined Speed Limits) Order 202\*.
5. 'The Essex County Council (Various Roads, Thorrington) (30mph Speed Limit and 40mph Speed Limit) Order 2024' is hereby revoked in its entirety. All restrictions shall remain in force by virtue of this new Order.

## Schedule 1

**'30mph Speed Limit'** and **'Restricted Roads'** in the Parish of Thorrington.

Road	Description
B1027 Clacton Road	From a point approximately 211 metres east of its junction with Church Road, westwards to a point approximately 750 metres west of its junction with Church Road, a total distance of approximately 961 metres.
Chapel Lane	For its entire length.
Church Road	For its entire length.
Clover Drive	For its entire length.
Hazel Close	For its entire length.
Honeysuckle Way	For its entire length.

## Schedule 2

**'40mph Speed Limit'** in the Parish of Thorrington.

Road	Description
B1029 Station Road and Frating Road	From its junction with the B1027 in a generally northerly direction for a total distance of approximately 1558 metres.
B1027 Tenpenny Hill and B1027 Clacton Road	From a point approximately 980 metres west of its junction with B1029 to a point approximately 750 metres west of its junction with Church Road, a total distance of approximately 1177 metres.
Great Bentley Road	From its junction with the B1029 Frating Road, Thorrington, northeast for approximately 154 metres.
