

**The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.39) Order 20\*\***

The Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

This order shall come into operation on \*\* \*\*\* 20\*\* and may be cited as The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.39) Order 202\*.

**The Essex County Council (Head Street, Colchester) (One Way - Exemption) Order**

The Essex County Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 3(2) and Part IV of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III to Schedule 9 to the Act, hereby make the following Order:

1. In this Order:  
"2016 Regulations" means The Traffic Signs Regulations and General Directions 2016.  
"pedal cycle" has the same meaning as in the 2016 Regulations.  
"cycle track" has the same meaning as in the 2016 Regulations.
2. No person shall, except under the direction of a Police Constable in uniform, prevent any person from causing any pedal cycle to proceed on the lengths of road and in the directions specified in schedule 1 to this order.
3. The restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
4. 'The Borough of Colchester (Various Streets) (One-Way) Order 1963 (hereinafter referred to as the '1963 Order') are varied to the extent that they affect the length of road as described in Schedule 1 of this new order (cited in Article 5). The other restrictions contained within the 1963 order shall remain in force by virtue of said order.
5. This Order shall come into operation on \*\* \*\*\* 20\*\* and may be cited as 'The Essex County Council (Head Street, Colchester) (One Way - Exemption) Order 20\*\* '.

Exemption for pedal cycles on the following length of road:

Head Street, Colchester city centre	From South to North and From North to South
