1. Minutes from the 1 July 2013 LHP meeting.

The minutes were agreed as a correct record.

2. Update on schemes approved

ECC HLO advised that the reports before Members included the latest information available from ECC's strategic partner - Essex Highways. Precise dates were not all available but the expectation was that all schemes/studies/designs would be completed in 2013/14. Specifically, the Panel decided:

DC1512c - Danes Way bus stop:

- Not to move the stop 8m to avoid objection from further resident
- To close current stop to mitigate existing objection from near resident (buses on this route already stop anywhere on request)
- A new scheme request for a lay-by outside shops
 Action: ECC HLO to request stop closure from bus stop team
 Action: ECC HLO to discuss new scheme request details with Cllr Aspinell and submit for validation

(Cllr Sparling declared a non-pecuniary interest under the Council's Code of Conduct by virtue of having a business in Danes Way)

DC1522 – Cycle Study:

• Given BBC had submitted its own study was the £25k overpriced Action: ECC S&EO to clarify with Transport Planning Team

DC1877 – Old Church Rd, Mountnessing – signs:

The Panel agreed to fund a £1300 top up to complete this scheme.

DC1868 – Ashwells Rd (j/w A128 & Mores Lane):

- Given the history of this location could the feasibility study/design into parking solutions be prioritised
- Could we ensure assessment of extending the 40mph limit and flashing school signs/VAS was included

Action: ECC HLO & SCSO to stress importance to D&C and inclusion of assessment of extending the 40mph limit and flashing school signs/VAS

NB: ECC HLO and TO visited site with Solagen re VAS. Owing to the proliferation of mature trees at the site, solar equipment would be unlikely to work without a complex relay system.

3. Schemes Requests

Members received a report giving an update on scheme requests.

A: Scheme requests - survey results received

A1: Station Road, West Horndon - zebra crossing

The CDPV² score was 0.06, where the threshold for eligibility was 0.2. Therefore the site did not meet the criteria for a crossing.

Action: ECC HLO to discuss implications with Cllr Hirst

A2: Tescos, Warley Hill - zebra crossing

The CDPV² score was 0.08, where the threshold for eligibility was 0.2. Therefore the site did not meet the criteria for a crossing. There was the option of a further survey once the store was open when actual pedestrian volumes and the desire line for crossing could be ascertained and tested. Panel recommended £890 for survey.

Tesco had informally indicated they might contribute £20k towards the estimated £50k cost, should a post opening survey meet eligibility. For ECC to accept funds, a legal agreement would be required (approx. £750) which the LHP may have to fund from revenue.

Action: ECC HLO to arrange survey once store was open

A3: 3 x Estates – 20 mph limit

The Panel agreed with Network Management's suggestion to trial a 20 mph limit on one residential estate (Hogarth) to use as a test case to see if the imposition of a 20 mph limit actually reduced speeds compared to the pre 20 mph surveys.

The Panel recommended a design and Traffic Regulation Order (TRO) - £5k.

A4: School Rd, Kelvedon Hatch - 20 mph limit

The Panel agreed with Network Management's suggestion to trial this 20 mph limit to use as a test case for local roads with schools, to see if the imposition of a 20 mph limit actually reduced speeds compared to the pre 20 mph surveys.

The Panel recommended a design and Traffic Regulation Order (TRO) - £4k.

A5: Chase Rd, Brentwood – speeding concerns

The results indicated good compliance of drivers observing the existing 30mph speed limit (mean av. 21.1 mph). No further action.

A6: Warley Hill – speeding concerns

The results indicated good compliance of drivers observing the existing 30mph speed limit (mean av. 27.2 mph). No further action.

A7: Mountnessing Lane, Doddinghurst - speeding concerns - 40 request

The results indicated good compliance of drivers observing the existing 60mph speed limit (mean av. 31.2 mph). No further action.

The Panel noted that this was a narrow twisty road where high speeds would be dangerous.

Network Management had advised that this was investigated under the County's speed limit review and no action was recommended at that time as the existing limit was appropriate and it would not be policy to change the recommendation. This was a standard rural road where de-restricted speed limits were the default and drivers were expected to drive with respect to road context and conditions.

A8: Devil's Head crossroads - safety concerns

Data suggests that since the 2 VAS signs (junction warning) on The Avenue and Eagle Way became fully functional as of 17 January 2012, Personal Injury Collisions (PICs) and speeds had reduced.

PICs from 11 (40 months prior to 17.1.12) to 2 (20 months since)

Speed survey results indicated good compliance of drivers observing the existing 60mph speed limit (34.5 - 37.5 mph) with an average reduction of 1.3 mph since installation.

The Panel noted that many constituents still favoured a roundabout or signalisation but such a scheme would be prohibitively expensive.

A casualty reduction report (2012) was presented to the LHP previously. An option for a £33k feasibility study/design into roundabout and signalisation options, to enable informed decision making by Engineering, Council and residents with regard to definitive costs and environmental impacts, was not recommended by the LHP.

The Panel requested an assessment of previous BBC research and plans (held at ECC) to ascertain whether a full feasibility study and design was a viable and more affordable option to fund. Such a study/design could at least establish clearer viability, options and costs for a scheme

The contractors who installed the VAS would be rectifying a minor problem with the pixels in the near future.

Action: ECC HLO to submit a validation request for a re-assessment of the viability and cost of a feasibility study including an assessment of previous BBC research and plans.

<u>A9: 3 x Safety Assessments for Brentwood zebra crossings</u>

These were requested following concerns regarding visibility of 3 zebra crossings (Kings Rd, Pondfield Lane, Hartswood Rd).

Action: ECC HLO would circulate in due course and report at the next Panel.

B: Scheme requests sent for validation - awaiting update

<u>B2: Tabors Corner – traffic signal phasing</u>

During peak periods drivers regularly ran the red light obstructing or driving through pedestrians during the period the green man was displayed.

The Panel recommended £3.8k, on advice from the Traffic Signals Team to a feasibility study including video evidence to investigate; modifying crossing to a stagger; changing the signal sequencing, relocating crossing or introduce some form of enforcement.

B3: Hall Lane – Shenfield – speeding concerns

Network management advised to extend the existing 30mph speed limit to include the properties that were currently outside the 30mph speed restriction.

The Panel recommended funds for design and Traffic Regulation Order (TRO) = $\pounds 4k$.

C: New Scheme requests

<u>C1: Childerditch Lane – advance give way sign before Devil's Head</u> **Action**: ECC HLO to discuss with Cllr. Hirst and submit a validation with regard to installing an advance give way sign.

C2: Shenfield Rd near Nuffield Hospital - zebra crossing

Note that recent utility works and resurfacing has removed the existing pedestrian refuge. A request has been sent to Highway Enquiries regarding its re-instatement.

The Panel recommended £890 from revenue for a pre-validation pedestrian vehicle survey (CDPV²) to establish eligibility.

<u>C3: Seven Arches Rd – zebra crossing for County High School</u> The Panel recommended £890 from revenue for a pre-validation pedestrian vehicle survey (CDPV²) to establish eligibility.

Action: Cllr. Kendall to advise ECC HLO proposed location.

(Cllr Kendall declared a non-pecuniary interest under the Council's Code of Conduct by virtue of a family member being struck by a car in Seven Arches Road).

C4: Great Warley St, Warley – speed related issues

A guest Cllr noted that Police had recently set up speed traps in the 40mph. Could we obtain data?

The Panel recommended £210 from revenue for a pre-validation speed survey.

Action: ECC HLO to liaise with Cllr. Kendall to prepare validation requests. **Action**: ECC SCSO to enquire with Police for speed trap data.

C5: Bird Lane, Warley – HGV concerns

The Panel recommended £210 from revenue for a pre-validation speed survey.

Action: ECC HLO to liaise with Cllr. Kendall to prepare validation request.

<u>C6: Church Rd, Kelvedon Hatch – 40 to 30 mph request</u> The Panel recommended £210 from revenue for a pre-validation speed survey.

<u>C7: Park That Bike - cycle scheme</u> Given funding constraints the Panel decided not to recommend this.

Action: ECC HLO to advise ECC Cycling Officer
