The Validation is an initial, brief assessment of the scheme, options for next steps and provisional cost estimates for the Rochford Local Highways Panel to consider for funding.

The validation will also assess whether the scheme request meets current implementation guidelines and satisfies ECC policy requirements. For some requests, a prevalidation survey is required.

	 Initial design brief issued May 2013 – with resident objections Report to LHP (Sept 2013) recommendation that proposed scheme does not go ahead, result of correspondence with other parties provided as evidence to decision. Option reviews offered to LHP for consideration.
	 Informal discussions with ECC Road Safety Team and ECC Networks Operations, who now support the scheme not going ahead.
	Cllr objection in local press (October 2013)
	Meeting Passenger Transport held (Nov 2013) to discuss ideas put forward as options. The concluding statement made was that the only way that the existing bus stop could be removed would be if a bus stop could be located in Rawreth Lane (Option 'A').
	Rawreth Parish Council – letter of objection (Dec 2013).
	Road Safety Audit (Stage 1/2) requested
	 Road Safety Audit identified many points of safety / design for both the proposed bus stop location and proposed layby location.
	Report to LHP (March 2014)
	Consultation with Strategy & Engagement and Passenger Transport who both were not in favour of the proposal. Congestion will not be removed and there were concerns as to the impact of new developments adjacent to Rawreth Lane.
	The proposed layby had major factors arising from the outline design with the main difficulties being new and improvement to existing drainage, predicted expensive diversion of BT stats. Signage relocation problems and insufficient space to safely locate the bus bay.
	 Report to LHP (June 2014) – Design Team recommend to LHP that this scheme does not go ahead. The principle of this scheme request is to reduce congestion at peak times at the mini roundabout junction of Rawreth Lane and Hullbridge Road. We are happy that all possible options have been made to reduce congestion at this point, but have to accept that we are unable to remove it from this junction with our proposals.
