## **BASILDON LOCAL HIGHWAY PANEL REPORT 2 - SCHEMES AWAITING FUNDING LIST**

This Schemes Awaiting Funding List identifies those scheme requests, which have been received for the consideration of the Basildon Local Highways Panel (LHP).

The agreed Basildon LHP Capital Budget for 2024/25 was £250,000. At the April 2024 Panel meeting Members made Scheme funding recommendations to a value of £108,500. There remains £141,500 of the 2024/25 LHP Capital Budget which the Panel can now use to make further scheme funding recommendations against.

There are currently Schemes Awaiting Funding with an estimated cost of £728,500 as shown in the summary below -
