The speed survey results do not indicate a speeding problem along Church Road Posted speed limit 30mph Eastbound average 23.2mph, Westbound average 22.2mph. Residents are concerned with the speed and volume of vehicles using Church Road to avoid the A13.

Ref: 11 - LCAS212022 - Triton Way, Thundersley – Traffic calming Validation Complete. Did not meet criteria. Average daily speed 25.5.mph Average daily speed 24.1 mph.

A member informed that residents are raising this as an issue and asked if the maximum speeds could be recorded in the speed surveys. This data is already included in the reports, there is another tab within the file that shows this. The information can also be passed on to Essex Police.

DM informed, if the item is removed from the list, it could be revisited and supplemented.

Request installation of railings to prevent dangerous crossing from the car park and a request for a zebra crossing by Holy Family Church.

<u>Benfleet High Road near Croft Road, Benfleet – Pedestrian Crossing</u> Does not meet criteria. Northbound Average daily speed 27.5 mph. Southbound Average daily speed 26.7mph. The PV2 for the location is calculated at 0.157 x 10⁸. Request for a crossing solution.

As previously raised under matters arising, a site visit is to be arranged. DM to check with Engineers.

Also, in 2023/24, part of the LHP funding is to be set aside for carriageway improvements.
