UTTLESFORD LOCAL HIGHWAY PANEL REPORT 2 - SCHEMES AWAITING FUNDING LIST

This Schemes Awaiting Funding List identifies those scheme requests, which have been received for the consideration of the Uttlesford Local Highways Panel (LHP).

The agreed Uttlesford LHP Capital Budget for 2024/25 was £118,000. At the October 2024 Panel meeting Members made Scheme funding recommendations to a value of £97,500. There remains £20,500 of the 2024/25 LHP Capital Budget.
